# Food Ingredients Asia 2007 Exhibition

This is the largest food ingredients exhibition in Southeast Asia and will allow you to access the market of 500 million people living in the region. The market for imported food ingredients is enormous with a \$1,6 billion market in Thailand alone. The increasing appetite for Western-style food products is boosting demand and sales. Approximately 7,500 buyers, and 250 exhibitors, are expected in 2007. The Trade Mission to Indonesia will allow you to access this market of 250 million people.

- Trade Mission to Indonesia. Airfare from Bangkok to Jakarta, 3 nights lodging, and individualized meetings with importers & distributors with interpreters provided, are all included. Limit of 2 per company. If not exhibiting at Fi Asia 2007 the cost is \$450.00 per person.

Cheese products, Dietary Supplements, Flavors/Aromas, Fruit Products, Herb / Spices / Nut Products, and Proteins.

Products must be at least 50% U.S. agricultural origin by weight, excluding added water and packaging.
