Here's the categorization of what we provided. This list does not cover the death that we told the Committee about on Monday evening.

To staff:

The chart reflected our update of what was originally provided the New York Times. In reviewing for this testimony and as a result of a request for additional information about detainee deaths in 2005, DRO identified an additional death from 2005. The total is 90 deaths (and was identified in Ms. Schriro's testimony) and the chart was submitted to you prior to that discovery. Here's the information on the death. We will update the chart with as much information as we have and send that to you as soon as possible. I apologize for the discrepancy.

Tanveer AHMAD, b2High,b6, M, native and citizen of Pakistan; died September 9, 2005 while in ICE custody at Monmouth (NJ) County Jail. On October 28, 2005, the Medical Examiner of the County of Monmouth released the autopsy report, which identified the cause of death as Natural and as a result of Occlusive Coronary Atherosclerosis.
