#### COD System Maintenance Planned For Sunday, April 19, 2009 (04/15/09)

The COD System will undergo routine maintenance on Sunday, April 19, 2009 from 1:30 A.M. until 11:00 A.M. (ET). In addition, the Student Aid Internet Gateway (SAIG) will be unavailable from 3:00 A.M. until 11:00 A.M. (ET) due to its regular Sunday morning maintenance. This activity will result in outages of certain COD System functionality for a period of time. Federal Student Aid appreciates your patience and understanding as it completes this important activity.

An explanation of how this activity will impact COD System availability and processing follows below. Please review this information to determine if processing at your school will be affected.

#### COD Web Site and System

- Users will not be able to submit or retrieve data via the <u>COD Web site</u> between 1:30 A.M. and 11:00 A.M. (ET).
- Batches submitted by schools via the SAIG between 1:30 A.M. and 3:00 A.M. (ET) will be held and not acknowledged back to schools until after the SAIG comes back up at 11:00 A.M. (ET).
- Schools attempting to transmit batches via the SAIG between 3:00 A.M. and 11:00 A.M. (ET) will receive an error message informing them that the SAIG is unavailable and that the data must be transmitted at a later time.

#### Direct Loan Electronic Master Promissory Note Web Site

• An individual will not be able to complete a new MPN electronically or retrieve an existing MPN that was completed electronically via the <u>Direct Loan Electronic Master</u> <u>Promissory Note (MPN) Web site</u> between 1:30 A.M. and 11:00 A.M. (ET).

An individual starting the process by 12:30 A.M. (ET) will be able to complete his or her MPN before the Web site becomes unavailable. An individual attempting to access the Web site after the cutoff time will see a Web site maintenance message and will not be able to start the process or retrieve an existing MPN.



#### TEACH Grant Agreement to Serve Web Site

• An individual will not be able to complete a new ATS electronically or retrieve an existing ATS via the <u>TEACH Grant Agreement to Serve (ATS) Web site</u> between 1:30 A.M. and 11:00 A.M. (ET).

An individual starting the process by 12:30 A.M. (ET) will be able to complete his or her ATS before the Web site becomes unavailable. An individual attempting to access the Web site after the cutoff time will see a Web site maintenance message and will not be able to start the process or retrieve an existing ATS.

## **Current Issues**

#### ATS/Pnote Search by Date Range Issues [04/01/09 (Updated 04/07/09)]

Federal Student Aid has identified two issues when schools search for Direct Loan Master Promissory Notes (MPNs) via the <u>COD Web site</u> for a specified school and date range. *Note:* The date range search will also return all Agreements to Serve (ATS) associated with that school.

#### Issue 1: The search results do not return all MPNs associated with that school.

The search results should include MPNs for any school associated with the MPN. Federal Student Aid has determined that unlinked MPNs are returned with the search results. However, for cases when an MPN is linked to an award from another school, the MPN is not returned with the search results. For cases when the MPN is linked to awards from more than one school, the MPN is only returned in search results for the school associated with the first linked award.

# Issue 2: The search results do not return more than 200 records and records are not the most current 200 records.

The search results should include all MPNs within the date range. Federal Student Aid has determined that a date range search for a long timeframe will not return more than 200 records and those records are not the most current MPNs. Federal Student Aid recommends that a school perform a date range search using a short timeframe.


#### Link on COD Web Site Welcome Page Not Working (04/02/09)

Federal Student Aid has discovered that users are receiving a "Service Unavailable" message when clicking the "Click here if you are looking for more information on Common Origination and Disbursement" link located on the Welcome page of the <u>COD Web site</u>. ## Weekly Reminders



When submitting student or borrower addresses to the Common Origination and Disbursement (COD) System, it is important that the correct tags are used, particularly when the student or borrower address is located in a U.S. Territory. These addresses are considered domestic addresses and should not be submitted as a foreign address with a Country Code. If these addresses are not submitted correctly, important correspondence from the COD System and the Direct Loan Servicing Center is delayed or not received.

When a student or borrower address is located in a U.S. Territory, the address should be treated as a domestic address and submitted to the COD System as follows:

#### Submitting Addresses for U.S. Territories via the COD Web site

When creating or updating a person record on the COD Web site, a school should select the U.S. Territory from the dropdown box in the State/Province field. A school should select the Country field as "Blank".

#### COD Computer-Based Training (04/17/09)

Federal Student Aid takes this opportunity to remind the community of the availability of the COD Computer-Based Training (CBT). The COD CBT includes enhancements that have been made to the COD System, the <u>COD Web site</u>, and associated Web sites and software products through June 28, 2008.

The COD CBT consists of component simulations and CBTs. Each COD CBT component is explained below. The electronic files associated with each component, as well as information about downloading and navigating the COD CBT, are available on the Information for Financial Aid Professionals (IFAP) Web site. Under the "Tools for Schools" section on the home page, click on <u>COD Computer-Based Training</u>.

The components of the COD CBT are as follows:

**COD System Simulations** – The COD System Simulations offer lessons that explain the <u>COD</u> <u>Web site</u> screens and functionality available to a school administrator. There are 14 lessons (one with two parts) with text to guide a user through each area of the <u>COD Web site</u>. By entering fictitious data, the user can explore basic navigation and functions of the <u>COD Web site</u> and practice locating and creating information in a safe environment that includes tips for assistance.

*Direct Loan Reports CBT* – The Direct Loan Reports CBT includes three lessons that explain the COD reports a school can use to assist with the reconciliation process for William D. Ford Federal Direct Loan (Direct Loan) awards.

*Grant Reports CBT* – The Grant Reports CBT includes three lessons that explain the COD reports a school can use to assist with the reconciliation process for Federal Pell Grant (Pell Grant), Academic Competitiveness Grant (ACG), and National Science and Mathematics Access to Retain Talent Grant (National SMART Grant) awards.

*Direct Loan (DL) Tools Simulation* – The DL Tools Simulation demonstrates how to use the DL Tools software to assist with the reconciliation process for Direct Loan awards. Although the simulation can be used both by schools that use the EDExpress for Windows software and

schools that do not use this software, the simulation is especially useful for schools that do not use the EDExpress software on a regular basis but are interested in a Direct Loan reconciliation resource.

*eMPN Online Simulations* – The eMPN Online Simulations offer a step-by-step walk through of the process for completing a Direct Loan Master Promissory Note (MPN) via the <u>Direct Loan</u> <u>Electronic MPN Web site</u>. There are three lessons with text to guide a user through student and parent aspects of the eMPN process.

#### 2008-2009 Pell Grant Deobligation Due To Verification Status "W" (04/16/09)

On April 15, 2009, Federal Student Aid deobligated 2008-2009 Award Year Federal Pell Grant (Pell Grant) disbursements that did not have a verification status updated from "W" to a valid status of "V" or "S". As noted in the warning message that Federal Student Aid sent to affected schools on April 1, 2009, these disbursements were considered overawards and reduced to a zero dollar amount (\$0.00), even though the disbursements were previously accepted in the COD System. This deobligation affected Pell Grant disbursements at approximately 300 schools.

A school affected by the deobligation will receive or see the following information:

- Receive a PGTX (PGTX09OP message class) file in the school's Student Aid Internet Gateway (SAIG) mailbox indicating the number of students and total amount of the decrease
- Receive a system-generated negative disbursement file (CRND09OP message class/ND • document type)
- Receive a new Electronic Statement of Account (ESOA) that reflects the decrease unless • there are other offsetting increase adjustments
- See a change in the school's Current Funding Level (CFL) that reflects the reduced disbursements

*Note:* This deobligation process will not affect a school that did not have students with a verification status of "W" just prior to April 15, 2009.

A school affected by the deobligation should carefully review the information below.

#### Verification Completed or Not Required

If verification has been completed as required or is not required and a school believes a student's 2008-2009 disbursement should not have been reduced to zero, the school must complete the following steps in this order:

- 1) The school must send an update to the verification status of the award, and the COD System must accept the update.
- 2) Once the verification status is updated to "V" or "S", the school may submit the actual disbursement (Disbursement Release Indicator or DRI equals "True") for the correct amount to the COD System for processing.



#### Notes:

- For the conditions under which each verification status code should be used, refer to <u>the</u> <u>September 28, 2007 Electronic Announcement posted on the Information for Financial</u> <u>Aid Professionals (IFAP) Web site</u>
- In the following two cases, it is acceptable for the verification status code field to be blank:
  - If the student was not selected for verification or if a selected transaction was received by the school after the student was no longer enrolled and the school has reported the verification status code as "W", the school should change the "W" to blank (nil = "True").
  - If the student was not selected for verification or if a selected transaction was received by the school after the student was no longer enrolled and the school has reported no verification status code to date, the school does not need to submit a verification status code and should leave the field blank (nil = "True").
- The school can perform steps 1 and 2 above in the same submission to the COD System if reported in the same student record.

#### Verification Deadline

Some of the 2008-2009 disbursements that were reduced to zero (\$0.00) may have been for students who are still within the allowable timeframe for submitting verification documentation/completing the verification process as will be specified in a forthcoming "Notice of Deadline Dates for Receipt of Applications, Reports, and Other Records for the 2008-2009 Award Year." This notice will be published in the <u>Federal Register</u> (and subsequently posted on the <u>IFAP Web site</u>).

If a school needs additional time to complete verification for an individual student in accordance with the allowable timeframe in the <u>Federal Register</u> notice, the school may resubmit a disbursement record with a value greater than zero (\$0.00) until September 30, 2009. After September 30, 2009, the COD System will no longer accept "W" as a valid verification status code for 2008-2009 Pell Grant awards.

#### 2006-2007 ACG CFL Reduction To G5 Net Drawdown On April 14, 2009 (04/15/09)

On April 14, 2009, Federal Student Aid reduced the Academic Competitiveness Grant (ACG) 2006-2007 Award Year Current Funding Level (CFL) to equal the Net Drawdown amount reflected in the COD System and in G5. This action applies to schools that had a CFL greater than their G5 Net Drawdown. As noted in the warning message that we sent to affected schools on March 12, 2009, this action was taken because disbursements and disbursement adjustments for the 2006-2007 Award Year should have already been submitted to the COD System for processing. This reduction affected approximately 40 schools.

A school affected by the April 14, 2009 CFL reduction to G5 Net Drawdown will be impacted as follows:

- Receive a text message (AGTX07OP Message Class) in the school's Student Aid Internet Gateway (SAIG) mailbox notifying the school of the reduction.
- Receive a new Electronic Statement of Account (ESOA) that reflects the reduction.
- See a change in the school's CFL that reflects the reduction.
- See a change in the school's authorization in G5 that reflects the reduction.

*Note:* The amount of the reduction will equal the difference between the school's CFL and Net Drawdown amount. This means that the amount of the reduction could equal as little as \$0.01.

# TEACH Grant Operational Implementation Guidance – COD System Implementation and Guidance Summary (04/17/09)

The College Cost Reduction and Access Act (the CCRAA), Pub. L. 110-84, authorized the Teacher Education Assistance for College and Higher Education (TEACH) Grant Program beginning with the 2008-2009 Award Year.

For TEACH Grant policy and operational guidance refer to the following postings on the Information for Financial Aid Professionals (IFAP) Web site:

- <u>Final Rule published on June 23, 2008 (73 FR 35472)</u> in the <u>Federal Register</u> provides the final regulations effective July 1, 2008 for the 2008-2009 Award Year.

**Participation Request Process Steps** – As outlined in the 10-step participation request process included in <u>Dear Colleague Letter GEN-08-07</u>, a school must complete Question 1, enter specified language in Section K/Question 69, and complete Section L via the <u>E-App Web site</u>. After completing these steps, the school must mail its signed and dated signature page to the Department of Education (the Department) per the instructions provided on the "Submit Application" page. To aid in expediting receipt of the school's signature page by the Department, the school may want to use an overnight delivery method.

**Participation Request Process Follow Up** – If a school does not receive a response regarding its request to participate in the TEACH Grant Program within two weeks of submitting the request, the school should contact the School Participation Team for the school's state. Contact information is available on the <u>E-App Web site</u>.

*School Addition to ATS Web Site* – Once a school is determined to be eligible to participate in the TEACH Grant Program, the school's name will be added to the TEACH Grant Agreement to Serve (ATS) Web site. As a general rule, Federal Student Aid will update the TEACH Grant ATS Web site on the Tuesday or Thursday most closely following notification of the school's eligibility. If a school has questions about the TEACH Grant ATS Web site, it should contact the COD School Relations Center.
