CIVIL PROCEEDINGS

AMICUS BRIEF FILED REGARDING TIME DEPOSITS

The Office of the General Counsel announced that the Commission filed a brief amicus curiae in the U.S. Court of Appeals for the Ninth Circuit stating the Commission's position that time deposits issued to persons in the United States by a foreign, non-U.S.-regulated bank are "securities" within the meaning of the Securities Act of 1933 and the Securities Exchange Act of 1934 if issued in an investment context but not if issued in commercial banking transactions. The Commission stated that the defendant issuer's status as a "bank" did not automatically exclude its debt instruments from the coverage of the securities laws, distinguishing Marine Bank v. Weaver, 455 U.S. 551 (1982), on the grounds that the issuer bank in Weaver was a domestic, federally-regulated and insured financial institution subject to a comprehensive scheme of banking regulation approved by Congress. The Commission also expressed the view that damages based solely on losses resulting from currency devaluation should not be awarded to purchasers of unregistered time deposits under Section 12(1) of the Securities Act for violation of the Act's registration provisions. (Wolf v. Banco Nacional de Mexico (Banamex), 9th Cir., No. 83-1534). (LR-10023)

REBENSTORF FOUND IN CONTEMPT OF COURT; PERMANENT RECEIVER APPOINTED

The Los Angeles Regional Office announced that on May 16 the Honorable Francis Whelan, Judge of the District Court for the Central District of California, after a hearing, entered an Order appointing Permanent Receiver. The Order directs Monte Krissman of Los Angeles, California to take control of Goldfield Deep Mines Company of Nevada, AAA Financial Corporation of Nevada (Triple A) and City Continental Financial, A.G. Mr. Krissman was previously appointed temporary receiver in this action.

Further, pursuant to the Commission's Application, Judge Whelan, on May 10, found John C. Rebenstorf III, Goldfield's president, in contempt of Court and ordered him imprisoned until such time as he returned to the receiver approximately \$130,000 in cashier's checks removed from corporate bank accounts on March 31. However, the Court stayed the order until May 16, at which time Rebenstorf tendered the checks to the receiver.

Finally, on May 20, Judge Whelan found Rebenstorf in contempt of court and entered an Order directing him to return \$9,300, also removed from corporate bank accounts, to the receiver. The order requires Rebenstorf to return the money by June 6. (SEC v. Goldfield Deep Mines Company of Nevada, et al., U.S.D.C. C.D. CA, Civil Action No. 83-2013 FW). (LR-10021)

INVESTMENT COMPANY ACT RELEASES

AMERICAN OPTION AND EQUITY FUND, INC.

An order has been issued by the Commission on its own motion, pursuant to Section 8(f) of the Act, declaring that American Option and Equity Fund, Inc., registered under the Act as an open-end, diversified, management investment company, has ceased to be an investment company. (Rel. IC-13305 - June 7)

PRUCO LIFE SERIES FUND, INC.

An order has been issued pursuant to Section 6(c) of the Act on an application filed by Pruco Life Series Trust, Inc. exempting it, subject to certain conditions, from the provisions of Section 2(a)(41) of the Act and Rules 2a-4 and 22c-1 thereunder to permit it to compute the net asset value per share of its Money Market Portfolio using the amortized cost method of valuing portfolio securities. PLIGROWTH FUND, INC.

An order has been issued pursuant to Section 8(f) of the Investment Company Act of 1940 on an application by Pligrowth Fund, Inc., registered under the Act as an open-end, diversified, management investment company, declaring that it has ceased to be an investment company. (Rel. IC-13307 - June 7)

AARP U.S. GOVERNMENT MONEY MARKET TRUST

A notice has been issued giving interested persons until July 5 to request a hearing on an application filed by AARP U.S. Government Money Market and other funds in the Federated group of investment companies and their investment advisers, requesting an order, pursuant to Sections 6(c) and 17(b) of the Investment Company Act of 1940, exempting them from the provisions of Sections 17(a)(1), 17(a)(2), and 17(e)(1) of the Act with respect to certain securities transactions with affiliated banks. HOLDING COMPANY ACT RELEASES

CENTRAL AND SOUTH WEST CORPORATION

The Commission has authorized a proposal by Central and South West Corporation, a registered holding company, and its six subsidiaries, to increase the short-term borrowing level for Transok Pipeline Company, subsidiary of Public Service Company of Oklahoma, to \$30 million. NOTICE OF EFFECTIVENESS OF PROPOSED RULE CHANGES

Proposed rule changes filed by the following have become effective in accordance with Section 19(b)(3)(A) of the Securities Exchange Act of 1934: The Boston Stock

Exchange, Inc. (SR-BSE-83-4) to amend Article XIII, Section 1 of the Constitution to increase the membership transfer fee from \$250 to \$500.
