ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS AGAINST JACKSON MORRIS AND MARK GOULD INSTITUTED AND SETTLED

On April 3, the Commission instituted and simultaneously settled public administrative proceedings against attorney Jackson Morris (Morris) and stock consultant Mark Gould (Gould) of Tampa and Clearwater, Florida, respectively, for their participation in an unregistered distribution of stock during 1998.

Morris and Gould received shares of PSA, Inc. from a group of stock promoters who completed a reverse merger for PSA, Inc. with a publicly traded shell company. PSA, Inc. was a start-up transportation company, which has no relation to the former Pacific Southwest Airlines that operated in California in 1984. The Commission alleged that in approximately April 1998, these promoters transferred 100,000 shares of PSA, Inc. to Gould and 50,000 shares of PSA, Inc. to Morris, as payment for Morris' legal services and Gould's consulting services, then orchestrated a "pump and dump" securities fraud scheme involving PSA, Inc. Morris and Gould knew that the promoters held a large block of PSA, Inc. shares and that the promoters planned to distribute their shares into the marketplace. Between approximately April and September 1998, Morris and Gould participated in an unregistered distribution of their PSA, Inc. shares by selling their shares into the market absent a valid registration with the Commission.

As a result of these proceedings, Morris and Gould consented to a cease and desist order preventing them from committing any future violation of Sections 5(a) and 5(c) of the Securities Act. Morris and Gould consented to the administrative order without admitting or denying the allegations. (Rel. 33-7966; File No. 3-10450)

ADMINISTRATIVE PROCEEDINGS INSTITUTED, FINDINGS MADE AND SANCTIONS IMPOSED AGAINST GARRY ISAACS

On April 3, the Commission issued an Order Instituting Public Administrative Proceedings Pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934, Making Findings and Imposing Remedial Sanctions (Order) against Respondent Garry P. Isaacs (Isaacs) of Branson, Missouri. Isaacs was associated with Tamarack Financial Inc., a registered broker-dealer, as its principal and sole shareholder. Isaacs submitted, and the

Commission accepted, an Offer of Settlement whereby he consented, without admitting or denying the findings contained therein except as to jurisdiction, to the entry of this Order. The Commission's Order finds that on September 20, 2000, a Judgment of Permanent Injunction and Other Relief was entered by consent against Isaacs, in the Southern District of Florida, permanently enjoining him from future violations of the registration and antifraud provisions of the federal securities laws (SEC v. Tamarack Funding Corp., et al., Civil Action No. 00-6730-CIV-HUCK, S.D. Fla.). The Commission, based upon the findings and Isaacs' consent, permanently barred Isaacs from association with any broker-dealer. (Rel. 33-7967; 34-44146; File No. 3-10451)
