HOLDING COMPANY ACT RELEASES

THE NATIONAL GRID GROUP PLC, ET AL.

An order has been issued authorizing National Grid USA (Grid), a registered holding company and an indirect wholly-owned subsidiary of The National Grid Group PLC, a registered public utility holding company, and its electric public utility subsidiary companies, Granite State Electric Company, Massachusetts Electric Company (Mass Electric), Nantucket Electric Company (Nantucket), The Narragansett Electric Company (Narragansett), New England Power Company, New England Electric Transmission Corporation, New England Energy Incorporated, New England Hydro-Transmission Electric Company, Inc., New England Hydro-Transmission Corporation, and National Grid USA Service Company, Inc. (Service Company) to increase their total amount of short-term borrowings by borrowing under the Grid intrasystem money pool, by borrowings from banks, and/or through the issuance of commercial paper in the following amounts, through May 31, 2003: (1) \$125 million for Mass Electric; (2) \$1 million for Nantucket; (3) \$45 million for Narragansett; and (4) \$48 million for Service Company. SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change (SR-CBOE-00-49) submitted by the Chicago Board Options Exchange to amend certain market maker eligibility requirements for participation on the Standard & Poor's 500 Index. (Rel. 34-44197)

The Commission approved a proposed rule change (SR-GSCC-00-05) by the Government Securities Clearing Corporation. The rule change allows securities lenders to deliver comparable securities, cash, or U.S. treasury bills, notes, or bonds to satisfy delivery and collateral allocation requirements in connection with their GCF Repo activity. The proposed rule change also allows GSCC to alter its risk management

procedures associated with the GCF Repo service to conform to mortgage-backed securities (MBS) market practice. (Rel. 34-44206)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-Phlx-2001-47) filed by the Philadelphia Stock Exchange to adopt an annual fee of \$200 for members and participants retention and renewal of the print loose leaf subscription to the Phlx Guide, containing the charter, By-Laws and rules of the Exchange has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of April 23. (Rel. 34-44198)

APPROVAL OF CONDITIONAL EXEMPTION

The Commission approved an application for a conditional exemption submitted under Section 36 of the Securities Exchange Act of 1934 by the National Association of Securities Dealers relating to the operation of a software development company by the Nasdaq Stock Market, Inc. Publication is expected in the Federal Register during the week of April 23. (Rel. 34-44201)
