### RICHARD LINDSEY TO TESTIFY

## HOLDING COMPANY ACT RELEASES

---

### GPU, INC.

A supplemental order has been issued correcting an order issued by the Commission on March 26, 1997 (HCAR No. 26694), authorizing, among other things, GPU, Inc., a registered public utility holding company, to guarantee, through December 31, 2000, up to \$150 million of the debt and other obligations of subsidiaries newly-formed to engage, pursuant to Rule 58, in the brokering and marketing of electricity, gas and other energy commodities. The supplemental order provides that GPU International, Inc., a wholly owned subsidiary company of GPU, may engage directly and/or GPU may engage indirectly through other existing subsidiaries, in the business of brokering and marketing a variety of energy commodities and in providing incidental related services to customers. CENTRAL AND SOUTH WEST CORPORATION, ET AL.

A supplemental order has been issued authorizing Central and South West Corporation (CSW), a registered holding company, and four of its utility subsidiaries (Subsidiaries) to amend the Subsidiaries' respective Articles of Incorporation to eliminate a provision limiting the issuance of debt securities, authorize CSW to acquire shares of preferred stock of the Subsidiaries pursuant to a cash tender offer, authorize the Subsidiaries to issue and sell junior subordinated debentures and tax deductible preferred securities (together, Preferred Securities) through December 31, 2001, and related transactions. Jurisdiction has been reserved over the issuance and sale of Preferred Securities by CSW and related transactions, pending completion of the record. (Rel. 35-26703)
