INVESTMENT COMPANY ACT RELEASES

GNA VARIABLE INVESTMENT ACCOUNT, ET AL.

An order has been issued to GNA Variable Investment Account (Account) and Great Northern Insured Annuity Corporation (GNA) approving the substitution of certain securities held by the Account to fund variable annuity contracts issued by GNA. (Rel. IC-21905 - April 18)

VALLEY FORGE LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until May 13 to request a hearing on an application filed by Valley Forge Life Insurance Company (VFLIC), Valley Forge Life Insurance Company Variable Annuity Separate Account (Separate Account), and CNA Investor Services, Inc. (collectively, Applicants). Applicants seek an order under Section 6(c) of the Investment Company Act granting exemptions from Sections 26(a)(2)(C) and 27(c)(2) of the Act to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Separate Account or any other separate account (Other Accounts) established in the future by VFLIC to support certain flexible premium individual deferred variable annuity contracts (Contracts) as well as other variable annuity contracts issued in the future by VFLIC, through the Account or Other Accounts, which are materially similar to the Contracts. HOLDING COMPANY ACT RELEASES

ALLEGHENY POWER SYSTEM, INC., ET AL.

A supplemental order has been issued authorizing a proposal by Allegheny Power System, Inc. (Allegheny), a registered holding company, and its wholly owned subsidiary companies, Allegheny Power

Service Corporation, Allegheny Generating Company, Monongahela Power Company, The Potomac Edison Company and West Penn Power Company (collectively, Applicants). By prior Commission order, Applicants may incur short-term debt during the period December 31, 1995 through December 31, 1997, subject to certain aggregate limits. Applicants now propose for Allegheny to increase the aggregate limit on its short-term debt financing from \$165 million to \$400 million. (Rel. 35-26506)
