COMMISSION MEETINGS

ENFORCEMENT PROCEEDINGS

PERMANENT INJUNCTION AND OTHER EQUITABLE RELIEF ORDERED AGAINST HARRY WATSON, TRACY FRENCH AND DELTAUR PARTNERS

The Commission announced that on October 17 a final judgment was entered against Harry Watson, Tracy French and Deltaur Partners. The Commission's complaint alleges that Watson, French and Deltaur Partners procured investors for Kenton Capital, Ltd.'s fraudulent "bank instrument" trading programs. The complaint further alleges that Watson, French and Deltaur were paid at least \$60,000 in commissions by Kenton Capital for procuring such investors.

Without admitting or denying the Commission's allegations, Watson, French and Deltaur consented to the entry of a final judgment permanently enjoining them from future violations of Sections 5(a), 5(c) and 17(a) of the Securities Act of 1933, Sections 10(b) and 15(a) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder, and Section 203(a) of the Investment Advisers Act of 1940, and ordering them to disgorge, jointly and severally, \$60,000, plus prejudgment interest of \$3,709.90, for a total disgorgement sum of \$63,709.90, within one year. The judgment further orders Watson, French and Deltaur to pay, jointly and severally, a civil penalty of \$60,000. Based upon their inability to pay either disgorgement or a penalty at this time, the civil penalty shall be waived if full

disgorgement is paid within one year.

On May 3, 1995, the Court issued a temporary restraining order and an asset freeze in this action. The terms of those orders were generally carried over into a preliminary injunction on June 23, 1995. On July 18, 1996, the Court entered final judgments against Joseph Silvestri, Charles Smith and Atlantic Pacific Guarantee Corporation. For further information see Lit. Rel. INVESTMENT COMPANY ACT RELEASES

PUTNAM RESEARCH ANALYSTS FUND

An order has been issued under Section 8(f) of the Investment Company Act declaring that Putnam Research Analysts Fund has ceased to be an investment company. (Rel. IC-22295 - October 23)

DEUTSCHE BANK AG

A notice has been issued giving interested persons until November 18 to request a hearing on an application filed by Deutsche Bank AG for an order that would supersede an existing order granting conditional exemptive relief from Section 17(f) of the Act. The requested order would allow certain foreign subsidiaries of applicant to maintain assets of registered investment companies in custody, in accordance with an agreement among applicant, the investment company (or its custodian), and the foreign subsidiary. The requested order would also allow these foreign subsidiaries to maintain such assets pursuant to a custody agreement between applicant and the investment company (or its custodian) and a separate subcustodian agreement between applicant and the foreign subsidiary.
