ENFORCEMENT PROCEEDINGS

MICHAEL MCGAHEE SETTLES ADMINISTRATIVE PROCEEDING AGAINST HIM

On December 24, the Commission issued an order instituting public administrative proceedings under the Securities Exchange Act of 1934 against Michael Donald McGahee, and simultaneously accepted McGahee's Offer of Settlement. The Order provides that McGahee be barred from association with any broker, dealer, municipal securities dealer, investment adviser or investment company; provided, however, that after two years from the date of this Order, he may reapply to become so associated in a nonproprietary, nonsupervisory capacity.

Without admitting or denying the findings, McGahee consented to the issuance of the order which found that on December 6 McGahee was permanently enjoined from violations of Section 17(a) of the Securities Act of 1933, and Section 10(b) of the Securities Exchange Act of 1934, and Rule 10b-5 thereunder, by the United States District Court for the Northern District of Texas (Dallas Division) [SEC v. Geoffrey Paul Adams, et al., 3:96CV-0300-H]. McGahee consented to the imposition of the permanent injunction without admitting or denying any of the allegations contained in the Commission's complaint against him.

The Commission's complaint alleged that McGahee participated in the sale of over \$3 million in interests or shares in the GPA Growth Fund and its pooled brokerage accounts to over 100 people. Further, the complaint alleged that McGahee made material misrepresentations and omissions of material fact in connection with the offer and sale of GPA Growth Fund shares, concerning, among other things, the rate of return on the investments and the use of proceeds. HOLDING COMPANY ACT RELEASES

NEW ENGLAND ELECTRIC SYSTEM, ET AL.

An order has been issued authorizing a proposal by New England Electric System (NEES), a registered public-utility holding company, its power marketing subsidiary company, NEES Energy, Inc. (NEES Energy), and NEES Energy's proposed power marketing subsidiary, AllEnergy Marketing Company, L.L.C. (AllEnergy LLC), whereby NEES and NEES Energy will, directly and indirectly, form and finance AllEnergy LLC in amounts of up to \$50 million, through December 31, 2001, in a joint venture with Eastern Enterprises, an exempt public-utility holding company. AllEnergy LLC may issue and NEES and NEES Energy may guarantee short-term notes in aggregate outstanding amounts of up to \$20 million. (Rel. 35-26633)

COLUMBIA GAS SYSTEM, INC., ET AL.

An order has been issued authorizing Columbia Gas System, Inc. (Columbia), a registered holding company, its distribution subsidiaries, Columbia Gas of Ohio, Inc., Columbia Gas of Pennsylvania, Inc., Columbia Gas of Kentucky, Inc., Columbia Gas of Maryland, Inc. and Commonwealth Gas Services, Inc., and its nonutility subsidiaries to provide for their internal and external financing through December 31, 2001. Columbia has also been authorized to finance the acquisition of exempt wholesale generators and foreign utility companies, as those terms are defined respectively in Sections 32 and 33 of the Public Utility Holding Company Act of 1935, as amended. SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

A proposed rule change filed by the New York Stock Exchange to add a fee for additional SPAR feed lines for specialists, (SR-NYSE-96-35) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of December 30. (Rel. 34-38075)

The Commission received a proposal (SR-NYSE-96-37) from the New York Stock Exchange to clarify that transactions in baskets that include American Stock Exchange, Inc. listed securities effected through NYSE Crossing Session II are deemed to constitute use of Exchange facilities, as described in Article II, Section 6 of the NYSE Constitution. Publication of the notice is expected in the Federal Register during the week of December 30. (Rel. 34-38078)

PROPOSED RULE CHANGE

The Chicago Board Options Exchange filed a proposed rule change (SR-CBOE-96-78) to amend its Rule 6.3B relating to trading halts due to extraordinary market volatility (Circuit Breaker Provisions) to adopt new thresholds for triggering its Circuit Breakers. Publication of the proposal is expected in the Federal Register during the week of December 30. (Rel. 34-38080)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change submitted by the Chicago Stock Exchange (SR-CHX-96-27) relating to permanent approval of program for automatic execution of limit orders. Publication of the proposal is expected in the Federal Register during the week of December 30. (Rel. 34-38082)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposal filed by the American Stock Exchange (SR-Amex-96-43) to extend its trading hours to permit the execution of matched orders for Exchange-listed securities which are part of a basket trade being done in large part on the New York Stock Exchange's Crossing Session II. Publication of the approval order is expected in the Federal Register during the week of December 30. (Rel. 34-38077)
