ENFORCEMENT PROCEEDINGS

CIVIL ACTION AGAINST AMERICAN INTERNET PARTNERS, INC., ET AL.

The Commission announced that it sued Steven P. Hevell and his companies American Internet Partners, Inc., American Internet Partners San Jose, ConnectTel Communications, Inc., and Jim D. James to stop an on-going securities fraud. The SEC obtained a Temporary Restraining Order and froze the assets of the Defendants, who live in Orange County. Hevell and his other companies are already defendants in another SEC fraud case, SEC v. Microwest Industries, Inc., CV 97-9150 CAS, filed last September. The SEC filed both complaints in federal district court in Los Angeles.

The complaint alleges that from July 1997 until the SEC obtained the Temporary Restraining Order, the Defendants raised over \$1.06 million from the sale of unregistered securities to at least 56 investors. The investors are unsophisticated and live throughout the country. Furthermore, nearly 20 percent of the funds invested were retirement funds. The Defendants told investors that their money would be used to purchase an Internet service provider. The complaint alleges that Defendants spent only \$300,000 on Internet service equipment but did not buy an Internet service provider. The complaint further alleges that Defendants misused most of the investor funds. Defendants told investors that their money would not be used to pay sales commissions. However, over half of the investor funds (\$558,000) were paid to independent sales agents for commissions. In addition, Defendants paid at least \$76,000 to Hevell, the undisclosed promoter of this alleged investment scheme. Furthermore, Defendants transferred \$46,000 to a company in which Hevell has an interest. Defendants also used at least \$4,300 for Hevell's personal expenses, including his cellphone and go-cart racing hobby. Finally, the remaining investor funds, approximately \$76,000, were spent on operating expenses, including rent and employee salaries and bonuses.

The complaint seeks a preliminary injunction, permanent injunction and disgorgement against AIP, AIP San Jose, Hevell, and James for violating Sections 5 and 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder and against ConnectTel for violating Section 17(a) of the

Securities Act and Section 10(b) of the Exchange Act and Rule 10b-5. The Court set the hearing on the SEC's application for a preliminary injunction for Monday, February 23, 1998. [SEC v. American Internet Partners, Inc., American Internet Partners San Jose, ConnectTel Communications, Inc., Steven P. Hevell, and Jim D. James, Civil Action No. 98-1014 CAS, C.D. Cal.] (LR-15640)

COMMISSION ISSUES ORDER MAKING FINDINGS AND IMPOSING REMEDIAL SANCTIONS AGAINST DEREK WASHINGTON

On February 12, the Commission entered an Order Making Findings and Imposing Sanctions and a Cease and Desist Order (Cease and Desist Order) against Derek Washington (Washington) of Brooklyn, New York. The Commission accepted Washington's Offer of Settlement, pursuant to which Washington consented to a suspension from association with any broker, dealer, municipal securities dealer, investment adviser or investment company for a one-year period.

Previously, on August 27, 1997, the Commission instituted public administrative proceedings against Washington. The Order Instituting Administrative Proceedings (Order) pursuant to Section 8A of the Securities Act of 1933 (Securities Act) and Sections 15(b), 15B(c)(4), 19(h) and 21C of the Securities Exchange Act of 1934 (Exchange Act), alleged that Washington was a registered vice-president of a certain broker-dealer (broker-dealer) from August 1991 to August 1993. Although not registered with the broker-dealer since August 1993, Washington conducted unregistered underwriting business and rendered substantial assistance by, among other things, executing underwriting agreements, submitting solicitations for underwritings, executing transactions and placing orders. In addition, the Order alleged that Washington made material misrepresentations regarding the broker-dealer's registration status to various municipal issuers and other underwriting firms.

The Order alleged that as a result of the foregoing conduct, Washington committed and/or caused violations of Section 17(a) of the Securities Act and Sections 15(a)(1), 15B(a)(1), 15(c)(1) and 15B(c)(1) and 10(b) of the Exchange Act, and Rules 10b-5 and 15c1-2, thereunder, and Rules G-2 and G-17 of the Municipal Securities Rulemaking Board (MSRB). The Order further alleged Washington willfully aided and abetted violations of Sections 15(a)(1), 15B(a)(1), 15(c)(1) and 15B(c)(1) of the Exchange Act, and Rule 15c1-2 thereunder, and MSRB Rules G-2 and G-17. Washington consented to the Cease and Desist Order without admitting or denying the allegations of the Order. (Rel. 33-7504; 34-39650; File No. 3-9376)

INVESTMENT ADVISERS ACT RELEASES

NIKKO RESEARCH CENTER (AMERICA), INC.

An order has been issued on an application filed by Nikko Research Center (America), Inc. under Section 203A(c) of the Investment Advisers Act granting an exemption from Section 203A(a) of the Act. The order permits Nikko Research Center (America), Inc. to register with the SEC as an investment adviser. (Rel. IA-1699 - February 11)

SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-PHLX-98-05) filed by the Philadelphia Stock Exchange to amend Exchange Rule 229.07(c) relating to automatic price improvement has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of February 16. (Rel. 34-39640)

PROPOSED RULE CHANGE

The Depository Trust Company filed a proposed rule change (SR-DTC-97-12) that will allow DTC to establish procedures for an investor's voluntary redemption and sales service (IVORS) that will enable participants that hold certain financial assets, primarily units in Unit Investment Trusts, to redeem or sell such units through DTC's participant terminal system. Publication of the proposal is expected in the Federal Register during the week of February 16. (Rel. 34-39647)

WITHDRAWAL SOUGHT

A notice has been issued giving interested persons until March 4, 1998, to comment on the application of London Insurance Group, Inc. to withdraw its 6 7/8% Notes, due September 15, 2005, issued pursuant to the Indenture dated September 25, 1995, from listing and registration on the New York Stock Exchange.
