ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS INSTITUTED AGAINST LAWRENCE SIMMONS

The Commission today instituted and settled proceedings pursuant to Rule 102(e) of the Commission's Rules of Practice against Lawrence J. Simmons, Sensormatic Electronic Corporation's (Sensormatic) former Vice President of Finance. Without admitting or denying the findings contained in the Order, except that he admitted to the entry of an injunction, Simmons consented to the issuance of the Order which denies him the privilege of appearing or practicing before the Commission as an accountant, with the right to apply to resume appearing or practicing after five years.

The Commission's Order was based, in part, on the entry of a Final Judgment against Simmons by consent on March 27, 1998, which permanently enjoins him from violating Section 17(a) of the Securities Act of 1933, and Sections 10(b) and 13(b)(5) of the Securities Exchange Act of 1934 and Rules 10b-5, 13b2-1, and 13b2-2 thereunder, in the action styled, SEC v. Ronald G. Assaf et al., Civil Action No. 98-757 (EGS) (D.D.C.). The Commission's complaint, filed on March 25, 1998, alleged that Simmons violated the antifraud and certain other provisions of the federal securities laws in connection with his participation in a scheme to manipulate the quarterly revenue and earnings of Sensormatic. SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the American Stock Exchange (SR-Amex-98-18) relating to the elimination of fixed percentage tests for trading halts in index options has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the order is expected in the Federal Register during the week of April 20. (Rel. 34-39878)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change (SR-CBOE-98-03) submitted by the Chicago Board Options Exchange to codify the Exchange's process for allocating securities to market-maker trading crowds and designated primary market makers (DPMs). Publication of the approval order is expected in the Federal Register during the week of April 20. (Rel. 34-39879)

The Commission approved a proposed rule change submitted by the Philadelphia Stock Exchange (SR-Phlx-97-62) that would require each of its respective trading floor standing committees to consult with its corresponding quality of markets committee on all matters that are to be presented to the Phlx Board of Governors. The Commission approved a proposed rule change and granted accelerated approval to Amendment No. 2 to the proposed rule change submitted by the National Association of Securities Dealers (SR-NASD-97-69) relating to the tape recording of conversations. Publication of the proposal is expected in the Federal Register during the week of April 20. (Rel. 34-39883)

PROPOSED RULE CHANGES

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-98-04) relating to mandatory arbitration of claims involving exempted securities. Publication of the proposal is expected in the Federal Register during the week of April 20. (Rel. 34-39880)

The Pacific Exchange filed a proposed rule change (SR-PCX-98-16) to require Exchange approval before any telephonic or electronic communications device may be used on the floor of the Exchange. Publication of the proposal is expected in the Federal Register during the week of April 20. (Rel. 34-39881)
