U.S. SECURITIES AND EXCHANGE COMMISSION

LARRY N. COOK ENJOINED

The Fort Worth Regional Office announced that on July 2 the Honorable Robert W. Porter of the U.S. District Court for the Northern District of Texas signed an Order permanently enjoining Larry N. Cook, of Dallas, Texas, from further violations of the registration and antifraud provisions of the Securities Act of 1933 and the antifraud provisions of the Securities Exchange Act of 1934. Cook consented to the entry of the Order without admitting or denying the allegations in the Commission's complaint.

The complaint, filed on December 15, 1976, against HJH, Inc., Cappetro, Inc., Fossil Petroleum Corporation, Heinz Jurgen Hesse, Cook, and others, alleged that the defendants violated the registration and antifraud provisions of the Federal securities laws in connection with the offer and sale of fractional undivided working interests in more than 130 oil and gas wells located in West Virginia, Ohio, Kentucky and Texas to approximately 1,000 European investors. HORN AND HARDART COMPANY
