COMMISSION ANNOUNCEMENTS

SEC AND IMRO ISSUE DECLARATION ON INSPECTIONS

The U.S. Securities and Exchange Commission and the U.K. Investment Management Regulatory Organization (IMRO) today issued a joint Declaration on Cooperation and Supervision of Cross-Border Investment Management Activity. IMRO is a self-regulatory organization in the United Kingdom that has primary responsibility for the supervision of investment advisers within the U.K.

The Declaration gives the SEC a new mechanism to obtain information about registered investment advisers located abroad and thereby improve its ability to oversee their operations. There are currently 115 investment advisers registered with the SEC that are also members of IMRO with approximately \$270 billion under management. The United Kingdom thus has the largest number of U.S. registered advisers in any one country outside of the United States. (Press Rel. 95-80)

INVESTMENT COMPANY ACT RELEASES

the assets of the Account of a mortality and expense risk charge imposed under certain variable annuity contracts (Contracts). The order also applies to future contracts that are substantially similar in all material respects to the Contracts and that are issued through the Account or other future accounts by Skandia Life (Future Contracts) and to any other National Association of Securities Dealers member broker-dealer controlling, controlled by or under common control with Skandia Life that may serve in the future as distributor and/or principal underwriter for the Contracts or Future Contracts. AMERICAN SKANDIA LIFE ASSURANCE CORPORATION, ET AL.

An order has been issued, pursuant to Section 6(c) of the Investment Company Act exempting American Skandia Life Assurance Corporation (Skandia Life), American Skandia Life Assurance Corporation Variable Account B (Class 3 Sub-Accounts) (Account), and Skandia Life Equity Sales Corporation from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act to the extent necessary to permit the deduction from the assets of the Account of a mortality and expense risk charge imposed under certain variable annuity contracts (Contracts). The order also applies to future contracts that are substantially similar in all material respects to the Contracts and that are issued through the Account or other future accounts by Skandia Life (Future Contracts) and to any other National Association of Securities Dealers member broker-dealer controlling, controlled by or under common control with Skandia Life that may serve in the future as distributor and/or principal underwriter for the Contracts or Future Contracts. WITHDRAWALS SOUGHT

A notice has been issued giving interested persons until May 18 to comment on the application of Carrington Laboratories, Inc. to withdraw its Common Stock, \$.01 Par Value and the related preferred share purchase rights issued pursuant to its Rights Agreement dated September 19, 1991, from listing and registration on the American Stock Exchange. PROPOSED RULE CHANGE
