COMMISSION ANNOUNCEMENTS

CHAIRMAN LEVITT AND COMMISSIONER WALLMAN TO INITIATE SITE ON THE WORLD WIDE WEB FOR THE SEC

On Thursday, September 28, at 11:00 a.m., at the SEC's Operations Center, Chairman Levitt and Commissioner Wallman will officially initiate the agency's new World Wide Web site by becoming its first users. Following their connection to the system, the service will be available to the public, at no cost, world-wide. (Press Rel. 95-190)

ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS INSTITUTED AGAINST ANTHONY BENINCASA

The Commission announced that public administrative proceedings have been instituted against Anthony J. Benincasa. The Commission's Order Instituting Public Proceedings alleges that Benincasa, while employed as a registered representative with three different brokerage firms, aided and abetted a fraudulent scheme being operated by Peter T. Jones, an unregistered investment adviser, through Independence Asset Management (IAM).

The Order alleges that from at least 1985 through November 1993, Jones, through IAM and a predecessor company, engaged in a Ponzi scheme through which he raised at least \$9.2 million from over 400 investors. From approximately 1987 to November 1993, Benincasa willfully aided and abetted Jones' and IAM's violations of the antifraud provisions of the federal securities laws by, among other things, knowingly opening accounts which falsely characterized IAM as a partnership; forging signatures on new account forms; and making material misstatements to investors. The Order further alleges that, from July 1991 to November 1993, Benincasa willfully aided and abetted violations, by the broker-dealer where he was employed, of books and records provisions of the Securities Exchange Act of 1934.

The Order seeks appropriate remedial action against Benincasa, a cease and desist order, disgorgement together with reasonable interest, and the imposition of a civil penalty. (Rel. 33-7222; 34-36273; IA-1522)

INVESTMENT COMPANY ACT RELEASES

T. ROWE PRICE SPECTRUM FUND, INC., ET AL.

A notice has been issued giving interested persons until October 17 to request a hearing on an application filed under the Investment Company Act by T. Rowe Price Spectrum Fund, Inc., et al. Applicants request an order pursuant to Section 6(c) of the Act granting relief from Sections 12(d)(1)(A) and (B), and pursuant to Sections 6(c) and 17(b) granting relief from Section 17(a). Applicants further request an order pursuant to Rule 17d-1 under the Act to permit certain joint transactions otherwise prohibited by Section 17(d) and Rule 17d-1. The requested order, which would supersede two prior orders, would permit the Spectrum Fund to continue operating as a "fund of funds" while eliminating many of the restrictions from the prior orders. VANGUARD STAR FUND, ET AL.

A notice has been issued giving interested persons until October 17 to request a hearing on an application filed by the Vanguard STAR Fund, et al. for an order under Section 6(c) of the Investment Company Act exempting applicants from Section 12(d)(1) of the Act, under Sections 6(c) and 17(b) of the Act exempting applicants from Section 17(a) of the Act, and pursuant to Section 17(d) of the Act and Rule 17d-1 thereunder. The requested order would supersede a prior order. The prior order permits the Vanguard STAR Fund to operate as a "fund of funds," subject to the limitation that the Vanguard STAR Fund may not acquire more than 10% of the outstanding voting shares of any acquired fund. The requested order would permit the Vanguard STAR Fund to acquire up to 100% of the voting shares of any acquired fund. The requested order would also permit the boards of trustees/directors of the funds constituting the Vanguard Group of Investment Companies to modify the funds' service agreement to provide that the STAR Fund may become a member of The Vanguard Group of Investment Companies without bearing duplicative capital contribution or expense allocation costs. HOLDING COMPANY ACT RELEASES

GENERAL PUBLIC UTILITIES CORPORATION

A notice has been issued giving interested persons until October 16 to request a hearing on a proposal by General Public Utilities Corporation (GPU), a registered holding company. By prior Commission order, GPU was authorized to issue and sell, through December 31, 1995, up to 2.5 million shares of its common stock, \$2.50 par value (Common Stock) pursuant to a Dividend Reinvestment and Stock Purchase Plan (Plan). GPU now proposes to extend to December 31, 2000 the time it may issue and sell authorized but unissued and reacquired shares of Common Stock under the Plan. (Rel. 35-26378)

LEIDY HUB, INC., ET AL.

A supplemental order has been issued in connection with a proposal by National Fuel Gas Company (NFG), a registered public utility holding company, and Leidy Hub, Inc. (Leidy Hub), its nonutility subsidiary. By order dated August 31, 1995 (HCAR No. 26365), Leidy Hub was authorized to acquire an interest in a company formed to develop, implement and operate an electronic gas trading and nomination system. A supplemental order clarifies that NFG and Leidy Hub shall submit to the Commission certain reports in connection with that transaction. (Rel. 35-26379)

AEP GENERATING COMPANY, ET AL.

An order has been issued authorizing Indiana Michigan Power Company (I&M), a public-utility subsidiary company of American Electric Power Company, a registered holding company, and its associate companies AEP Generating Company, Appalachian Power Company, Columbus Southern Power Company, Kentucky Power Company, and Ohio Power Company to modify the method of calculating the cost of capital applicable to I&M's investment in the River Transportation Division. (Rel. 35-26380)

An order has been issued granting the application of the New York Stock Exchange to strike from listing and registration Aileen, Inc., Common Stock, \$0.001 Par Value. (Rel. 34-36266)

An order has been issued granting the application of the New York Stock Exchange to strike from listing and registration Club Med, Inc., Common Stock, \$1.00 Par Value. (Rel. 34-36267)

An order has been issued granting the application of the Boston Stock Exchange to strike from listing and registration Oliver Transportation, Inc., Common Stock, \$.001 Par Value and Redeemable Common Stock Purchase Warrants. (Rel. 34-36268)

APPROVAL OF PROPOSED RULE CHANGES

The Commission has granted approval to two proposed rule changes (SR-Phlx-95-20 and SR-Phlx-95-21) and has granted accelerated approval to Amendment No. 1 to each of the proposed rule changes filed by the Philadelphia Stock Exchange relating to the listing of customized foreign currency options on the Italian lira and Spanish peseta. Publication of the notice and order is expected in the Federal Register during the week of September 25. (Rel. 34-36255; International Series Rel. 858)

The Commission approved a proposed rule change (SR-PHLX-95-31) submitted by the Philadelphia Stock Exchange which amends the PHLX's rules to require PHLX members who trade non-PHLX listed option contracts and who are not members of the exchange where the options are traded to comply with the option position and exercise limits set by the exchange where the transactions are effected. Publication of the order is expected in the Federal Register during the week of September 25. (Rel. 34-36257)

The Commission approved a proposed rule change filed by National Securities Clearing Corporation (SR-NSCC-95-09) relating to modifications to its procedures to allow the processing of voluntary reorganizations with protect periods of three days or greater. Publication of the approval order is expected in the Federal Register during the week of September 25. (Rel. 34-36258)

PROPOSED RULE CHANGES

The Philadelphia Stock Exchange filed a proposed rule change (SR-Phlx-95-32) and Amendment No. 1 to the proposed rule change relating to broker-dealer orders on PACE. Publication of the proposal is expected in the Federal Register during the week of September 25. (Rel. 34-36263)

The Philadelphia Depository Trust Company filed a proposed rule change (SR-PHILADEP-95-07) seeking to implement the Fully Automated Securities Transfer Reconciliation Accounting Control System on a permanent basis. Publication of the proposal is expected in the Federal Register during the week of September 25. (Rel. 34-36264)

The Philadelphia Stock Exchange filed a proposed rule change (SR-Phlx-95-66) to amend Phlx Rule 1066 by adding new paragraph (h), P/A Orders (Principal Acting as Agent); and Phlx Rule 1015 by adding new paragraph (c). The proposed rule change would provide certain orders placed in the name of floor traders on other options exchanges, but for the benefit of customers, with public customer volume guarantees on the Phlx. Publication of the proposal is expected in the Federal Register during the week of September 25. (Rel. 34-36271)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The Stock Clearing Corporation of Philadelphia and Midwest Clearing Corporation filed a proposed rule change (SR-SCCP-95-05 and SR-MCC-95-03) pursuant to Section 19(b)(3)(A) of the Securities Exchange Act and Rule 19b-4(e)(6) thereunder. The Commission has designated that the rules become effective upon filing. The proposed rule changes expand the comparison parameters for transactions in SCCP's and MCC's interfaces with the National Securities Clearing Corporation's Fixed Income Transaction System. (Rel. 34-36265)

WITHDRAWAL OF PROPOSED RULE CHANGE

The Options Clearing Corporation withdrew a proposed rule change (SR-OCC-95-01) that was filed pursuant to Section 19(b)(1) of the Securities Exchange Act. The proposed rule change clarified OCC's rules regarding the unavailability of current index values. (Rel. 34-36272)
