## COMMISSION ANNOUNCEMENTS

---

### FEE RATE ADVISORY

The continuing resolution (CR) on fiscal 1996 funding expired at midnight, Friday, December 15. Due to the fact that the Congress and the Administration did NOT enact a new CR, the fee rate for registration statements and other filings paid pursuant to Section 6(b) of the Securities Exchange Act of 1933 reverted to 1/50th of one percent of the offering amount, effective at 8:00 a.m. Monday, December 18.

Please be advised that a CR enacted after December 16 could restore the Section 6(b) fee rate to 1/29th of one percent effective as of December 16. In that event, filers who paid 1/50th of one percent would be required to pay an additional amount equal to the difference between the amount paid and 1/29th of one percent of the amount of the offering.

Filers should direct all questions regarding the fee rate to the Office of Filer Support at (202) 942-8900.

The Commission will issue further notices as appropriate to keep registrants informed of developments affecting the Section 6(b) fee rate. (Press Rel. 95-256)

## ENFORCEMENT PROCEEDINGS

---

### CEASE AND DESIST ORDER ISSUED AGAINST STANLEY GOODMAN

The Commission announced today an Order Instituting Proceedings, Making Findings and Imposing a Cease and Desist Order (Order) against Stanley Goodman (Goodman). Goodman consented to the entry of the Order without admitting or denying the Commission's findings.

The Order found that Goodman caused violations of the antifraud provisions of the federal securities laws and ordered him to cease and desist from committing or causing any violation, and committing or causing any future violation, of such provisions.

Specifically, the Order makes findings that from 1984 through 1989 two not-for-profit corporations, First Humanics Corp. (First Humanics) and its successor, International Elderly Care, Inc. (IEC), acquired 26 nursing homes through 26 public offerings of municipal and corporate bonds raising over \$107 million. In connection with two such offerings, Goodman, serving as company counsel for First Humanics and IEC, caused misrepresentations and omissions of material fact to be made concerning the promoter of the offerings; the promoter's control over the not-for-profit corporations as well as his regulatory history and numerous prior bond and business failures; the commingling of First Humanics revenues from earlier nursing home acquisitions; the use of proceeds from First Humanics offerings; and the nexus between IEC and First Humanics. #### COMMISSION SUSTAINS NASD DISCIPLINARY ACTION AGAINST LAWRENCE KLEIN

The Commission has sustained the disciplinary action taken by the National Association of Securities Dealers, Inc. (NASD) against Lawrence R. Klein, of Westlake Village, California. Klein formerly was associated in various registered capacities with Spectrum Securities, Inc. (Spectrum), an NASD member firm. The NASD found that Klein caused \$17,000 to be wired from the account of one set of customers to the account of another customer, and effected this transfer by forging his customers' signatures. The NASD concluded that Klein thereby violated Article III, Sections 1 and 19(a) of the NASD's Rules of Fair Practice, censured Klein, and barred him from association with any NASD member in any capacity, with the right to reapply after five years from the date of its decision.

Klein appealed only the sanctions imposed. The Commission concluded that the sanctions were neither excessive nor oppressive. The Commission found that the NASD had considered in mitigation Klein's previously clean disciplinary record, as well as certain personal difficulties and his efforts at rehabilitation. Noting that the NASD also had considered the seriousness of Klein's misconduct and that it amounted essentially to "stealing," the Commission found that, for the protection of investors and to deter similar misconduct by others, Klein should receive no greater leniency than that already extended. #### SUMMARY JUDGMENT ENTERED AGAINST GLENN SCHUSTER, A PENNY STOCK PROMOTER

The Commission announced that on December 13 a Final Judgment by Summary Adjudication was entered in United States District Court, Houston, Texas, against Glenn A. Schuster, permanently enjoining him from future violations of the antifraud provisions of the federal securities laws. The Commission's complaint, filed November 23,

1992, alleged that Schuster, a penny stock promoter, participated in a scheme involving the unlawful public offering of the securities of Bancus Richmond, Inc., (Bancus), and the subsequent distribution and manipulation of the company's shares in the over-the-counter market. The Final Judgment also orders Schuster to disgorge \$748,027.49, comprised of \$470,624.59, which represents the proceeds received from his unlawful sales of Bancus securities, plus \$277,402.90 in prejudgment interest. ## **INVESTMENT COMPANY ACT RELEASES**

---

### **THE DIVERSIFIED INVESTORS FUNDS GROUP, ET AL.**

A notice has been issued giving interested persons until January 8 to request a hearing on an application filed by The Diversified Investors Funds Group, et al. for an order pursuant to Section 6(c) of the Investment Company Act exempting applicants from Section 12(d) (1) of the Act; pursuant to Sections 6(c) and 17(b) of the Act exempting applicants from Section 17(a) of the Act; and pursuant to Rule 17d-1 under the Act permitting certain joint transactions in accordance with Section 17(d) of the Act and Rule 17d-1 thereunder. The requested order would permit applicants to create a "fund of funds" that initially will have three portfolios. Each portfolio would allocate substantially all of its assets among certain underlying funds in the same group of investment companies, which will be "feeder" funds in a "master-feeder" structure, without regard to the percentage limitations of Section 12(d)(1). Each feeder fund, in turn, would invest 100% of its assets in a corresponding series of an underlying "master" fund. (Rel. IC-21597 - December 13)

### **THE ONE HUNDRED FUND, INC., ET AL.**

A notice has been issued giving interested persons until January 8 to request a hearing on an application filed by The One Hundred Fund, Inc., et al. for an order under Section 6(c) of the Investment Company Act that would exempt applicants from Sections 13(a)(2), 13(a)(3), 18(f)(1), 22(f), and 22(g) of the Act; under Sections 6(c) and 17(b) of the Act for an exemption from Section 17(a)(1) of the Act; and pursuant to Section 17(d) of the Act and Rule 17d-1 thereunder. The order would permit the applicant investment companies to enter into deferred compensation arrangements with their independent directors. (Rel. IC-21598 - December 13)

### **INTERNATIONAL GROWTH TRUST**

An order has been issued under Section 8(f) of the Investment Company Act declaring that International Growth Trust has ceased to be an investment company. (Rel. IC-231599 - December 19)

**STATE STREET BANK AND TRUST COMPANY, ET AL.**

A notice has been issued giving interested persons until January 8 to request a hearing on an application filed by State Street Bank and Trust Company, et al. for an order under Section 6(c) of the Investment Company Act to exempt applicants from Section 12(d)(1) of the Act; under Sections 6(c) and 17(b) of the Act to grant an exemption from Section 17(a); and under Rule 17d-1 to permit certain transactions in accordance with Section 17(d) and Rule 17d-1. The order would permit State Street Bank, as agent for certain registered management investment companies or series thereof to invest cash collateral derived from securities lending transactions in shares of one or more series of Global Lending Trust. **HOLDING COMPANY ACT RELEASES**

**EUA COGENEX CORPORATION**

A notice has been issued giving interested persons until January 8 to request a hearing on a proposal by EUA Cogenex Corporation (Cogenex), a nonutility subsidiary of Eastern Utilities Associates, a registered holding company. Cogenex proposes to form a Delaware limited liability company (JV ESCO) with Westar Business Services, a nonaffiliated company, for the purpose of providing energy conservation services; guarantee third party loans obtained by JV ESCO; and provide goods and services to JV ESCO at prices not to exceed market prices pursuant to an exception from the requirements of Section 13(b) and Rules 90 and 91 thereunder. (Rel. 35-26432)

**HOPE GAS, INC., ET AL.**

A notice has been issued giving interested persons until January 8 to request a hearing on a proposal by Hope Gas, Inc. (Hope Gas) and CNG Producing Company (CNGP), both subsidiaries of Consolidated Natural Gas Company, a registered holding company, whereby Hope Gas will sell all of its oil and gas production properties to CNGP for their net book value of approximately \$4.6 million. (Rel. 35-26432)

**CENTRAL AND SOUTH WEST CORPORATION**

A notice has been issued giving interested persons until January 8 to request a hearing on a proposal by Central and South West Corporation (CSW), a registered holding company, to amend certain provisions of its Dividend Reinvestment and Stock Purchase Plan (Plan). Specifically, CSW proposes to increase the number of originally issued shares of its common stock that may be offered pursuant to the Plan from five million to ten million; permit non-shareholders of legal age who are residents of all fifty States

of the United States and the District of Columbia to participate in the Plan; increase the initial cash investment required for enrollment in the Plan by non-employees and non-retirees from \$100 to \$250; and change the frequency of investment in shares of common stock by the Plan from bi-monthly to weekly. ### DELISTING GRANTED

An order has been issued granting the application of the Boston Stock Exchange to strike from listing and registration Venture Seismic, Ltd., Common Stock, No Value. (Rel. 34-36586)

### WITHDRAWAL GRANTED

An order has been issued granting the application of Ocelot Energy Inc. to withdraw from listing and registration its Class B subordinate Voting Shares, No Par Value, on the American Stock Exchange. (Rel. 34-36593)

### PROPOSED RULE CHANGE

The American Stock Exchange filed a proposed rule change (SR-Amex-95-48) to amend its Equity Linked Note listing standards to provide issuer's with greater flexibility in the listing of these products. Publication of the Notice is expected in the Federal Register during the week of December 18. (Rel. 34-36578)

The New York Stock Exchange filed a proposed rule change (SR-NYSE-95-39) to amend its Equity Linked Debt listing standards to provide issuer's with greater flexibility in the listing of these products. Publication of the Notice is expected in the Federal Register during the week of December 18. (Rel. 34-36581)

The Pacific Stock Exchange filed a proposed rule change (SR-PSE-95-29) relating to the composition and duties of the Options Allocation Committee of the Exchange. Publication of the notice is expected in the Federal Register during the week of December 18. (Rel. 34-36592)

### APPROVAL OF AMENDMENT TO JOINT INDUSTRY PLAN

The Commission approved Amendment No. 6 to a Joint Industry Reporting Plan for Nasdaq/National Market securities traded on an exchange on an unlisted or listed basis, submitted by the National Association of Securities Dealers, and the Boston, Chicago and Philadelphia Stock Exchanges (File No. S7-24-89). The Commission's approval order extends the effectiveness of the Plan and extends certain exemptive relief granted by the Commission in conjunction with the Plan through December 29, 1995. (Rel. 34-36589)

## APPLICATION FOR EXEMPTION FROM REGISTRATION AS A CLEARING AGENCY

ProTrade, a Washington corporation, which has designed an options trading system that incorporates features of an options broker-dealer, an options exchange, and an options clearing agency, has applied for an exemption from registration as a clearing agency under Section 17A of the Securities Exchange Act of 1934. Publication of the notice of the application is expected in the Federal Register during the week of December 18. (Rel. 34-36587; File No. 600-28)

## APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change (SR-CBOE-95-63) filed by the Chicago Board Options Exchange to adopt a new rule concerning telephone solicitation and record-keeping. (Rel. 34-36588)

The Commission approved a proposed rule change submitted by the Chicago Stock Exchange (SR-CHX-95-24) relating to agency crosses between the disseminated exchange market. (Rel. 34-36590)

The Commission approved a proposed rule change submitted by the American Stock Exchange (SR-Amex-95-29) to revise its debt listing standards. (Rel. 34-36594)
