DECISIONS IN ADMINISTRATIVE PROCEEDINGS

DECISION REVOKING REGISTRATION OF MULLANEY, WELLS AND COMPANY FINAL

U.S. SECURITIES AND
EXCHANGE COMMISSION

The decision of an administrative law judge revoking the registration of Mullaney, Wells and Company, a Chicago broker-dealer, has become final. According to the decision, Mullaney, Wells made unlawful payments, ostensibly for computer services, to the investment adviser of a mutual fund in return for the fund's portfolio business, charged the fund excessive mark-ups on securities purchases, and failed to comply with recordkeeping provisions. DECISION BARRING JOHN WILLIAM AIRSMAN FINAL

The decision of an administrative law judge barring John William Airsman, of Salt Lake City, from association with any broker or dealer has become final. According to the decision, Airsman unlawfully sold unregistered stock of Epoch Corporation, and participated in manipulative activities involving Epoch stock. (Rel. 34-12808)

DELAWARE VALLEY INVESTMENT CLUB, INC. REVOKED

The Commission has revoked the registration of the Delaware Valley Investment Club, Inc. (Respondent), an investment adviser in Philadelphia, Pennsylvania and barred Robert H. Bomberger (Bomberger) of Philadelphia, Pennsylvania from association with any investment adviser. The sanctions were based on an offer of settlement submitted by Respondent and Bomberger who, without admitting or denying the allegations in the Commission's order for proceedings, consented to the findings of the Commission that Bomberger wilfully violated the antifraud provisions of the securities laws and that Bomberger was convicted in March 1976 of a felony involving the purchase and sale of securities. THE CHASE FUND OF BOSTON

An order has been issued on an application submitted by The Chase Fund of Boston and Shareholders' Trust of Boston, registered, open-end, diversified management investment companies, Phoenix Investment Counsel of Boston, Inc., the investment companies' investment adviser, Phoenix Equity Planning Corporation, the investment companies' principal underwriter, and Chase Investment Services of Boston, Inc., a subsidiary of the investment adviser and principal underwriter, permitting the limited sale at net asset value without a sales charge of shares of the investment companies when such shares are purchased by certain mini-account clients of Chase Investment Services of Boston, Inc. (Rel. IC-9454 - Sept. 22)

THE VALUE LINE INCOME FUND

A notice has been issued giving interested persons until October 15 to request a hearing on an application of The Value Line Income Fund, Inc., a registered open-end company, and its affiliate, The Value Line Development Capital Corporation, a registered closed-end company, and Liquidonics Industries, Inc., a portfolio affiliate of the funds, for an order pursuant to Rule 17d-1 under Section 17(d) of the Act permitting the funds to participate in a plan of recapitalization of Liquidonics. SEYMOUR FOODS

An order has been issued pursuant to Section 17(b) of the Act exempting from Section 17(a) of the Act the proposed sale by Seymour Foods, Inc. (Seymour) to Ben Voth (Voth),

and the proposed purchase by Voth, of Seymour's entire holdings of common stock issued by G F Industries, Inc. Seymour is a wholly-owned subsidiary of Source Capital, Inc., a registered closed-end diversified management investment company. (Rel. IC-9456 - Sept. 23)
