INVESTMENT COMPANY ACT RELEASES

BANKERS LIFE ASSURANCE COMPANY OF NEBRASKA

An order has been issued exempting Bankers Life Assurance Company of Nebraska, Bankers Life Assurance Company of Nebraska Separate Account V, and BNL Investment Corp. from the provisions of Sections 2(a)(32), 22(c), 26(a)(2), 27(c)(1), 27(c)(2), and 27(d) of the Investment Company Act and Rules 6e-3(T)(b)(12), 6e-3(T)(b)(13), and 22c-1. Relief is granted to permit a charge for state premium taxes incurred in connection with the premiums paid under certain flexible premium variable life insurance contracts and any successor contracts during the first contract year, to be deducted from the amount otherwise payable upon surrender or lapse prior to the eighth contract anniversary. (Rel. IC-15621 - March 12)

PRUDENTIAL-BACHE SECURITIES INC.

A notice has been issued giving interested persons until April 6 to request a hearing on an application of Prudential-Bache Securities, Inc. and Prudential Unit Trusts for an order granting exemption from Sections 14(a) and 19(b) of the Investment Company Act and Rule 19b-1 in connection with the operation of unit investment trusts. HOLDING COMPANY ACT RELEASES

NEW ENGLAND ELECTRIC SYSTEM

An order has been issued authorizing New England Electric System, a registered holding company, to issue and sell prior to December 31, 1990 an additional 5,000,000 of its authorized but unissued common shares under its Dividend Reinvestment Plan following an exception from competitive bidding. THE COLUMBIA GAS SYSTEM, INC.
