NOTICE OF COMMISSION MEETINGS

CHANGES IN THE MEETING: RESCHEDULING

The following item previously scheduled for Tuesday, October 20 has been rescheduled for Thursday, October 29 at 9:30 a.m.:

Consideration of whether to adopt Rule 6c-9 and Form N-6C9 under the Investment Company Act of 1940. Rule 6c-9 would provide an exemption from the provisions of the Act, under certain conditions, to permit foreign banks to offer their own debt securities or non-voting preferred stock in the United States without registering as investment companies or obtaining exemptive orders. The exemption would also be available where a foreign bank offers its securities in the United States indirectly through a finance subsidiary. The form would be filed by a foreign bank or foreign finance subsidiary to appoint a United States agent for service of process. FOR FURTHER INFORMATION, PLEASE CONTACT Ann M. ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS ORDERED AGAINST GERALD L. ZAIDMAN

The Commission ordered public administrative proceedings instituted under Section 15(c)(4) of the Securities Exchange Act of 1934 against Gerald L. Zaidman, president of Windsor Holding Corp., to determine whether Zaidman was a cause of Windsor's failures to comply with Section 13(a) of the Exchange Act and Rules 12b-20 and 13a-13 and Section 13(b)(2)(B) of the Exchange Act.

The Division of Enforcement alleges that Zaidman was a cause of Windsor's filing a quarterly report on Form 10-Q for the third quarter 1984 which contained materially false and misleading statements concerning Windsor's inventory by failing to take appropriate action when he learned that financial statements may have been overstated. The Division further alleges that Zaidman was a cause of Windsor's failure to devise and maintain a system of reasonably adequate internal controls for inventory and cash receipts and disbursements because he knew or should have known of deficiencies with such controls and failed to take reasonable steps to resolve the deficiencies in a timely manner. CIVIL PROCEEDINGS

ROBERT A. DIANNI ADJUDGED IN CIVIL CONTEMPT

The Boston Regional Office announced that on October 16 Judge A. David Mazzone, U.S. District Court for the District of Massachusetts, adjudged Robert A. DiIanni of Boston in civil contempt of Orders entered by the Court on August 7 and 17 for failing to comply with the Court's Orders to produce information concerning the amount and locations of investors' funds, an affidavit that he has legally satisfied the claims of all persons who invested with or through him, and letters from investors stating that their claims against DiIanni have been legally satisfied. The Court withheld imposition of a monetary or other sanction, but ordered DiIanni's attorney to provide to the Court by November 9: (1) a list of the locations and the amounts of investors' accounts; (2) a schedule of assets and funds available to satisfy those accounts; and (3) a plan, agreed to by the investors, for the liquidation of those assets. (SEC v. Robert A. DiIanni, DCMA, Civil Action No. 87-1891-MA). (LR-11583)

INVESTMENT COMPANY ACT RELEASES

THE MANUFACTURERS LIFE INSURANCE COMPANY OF AMERICA

An order has been issued granting The Manufacturers Life Insurance Company of America (Company), Separate Account Two of the Manufacturers Life Insurance Company of America, and ManEquity, Inc. exemptions from the provisions of Sections 26(a)(1) and 27(c)(2) of the Investment Company Act to permit the deduction of mortality and expense risk charges in connection with the issuance of certain variable annuity contracts. (Rel. IC-16069 - Oct. 21)

An order has also been issued granting the Company, Separate Account One of the Manufacturers Life Insurance Company of America, and ManEquity exemptions from the provisions of Sections 9(a), 13(a), 15(a), and 15(b) of the Investment Company Act and Rule 6e-2(b)(15) to permit the sale of shares of ManuLife Series Fund, Inc. to both variable annuity and variable life separate accounts of the Company. (Rel. IC-16070 - Oct. 21)

MITSUBISHI BANK OF CANADA

A notice has been issued giving interested persons until November 16 to request a hearing on an application filed by Mitsubishi Bank of Canada for an order exempting it from all provisions of the Investment Company Act so that it may offer U.S. dollar-denominated certificates of deposit and other debt securities in the United States. FIRST MIDWEST CORPORATION

A notice has been issued giving interested persons until November 16 to request a hearing on separate applications filed by First Midwest Corporation and First Midwest Capital Corporation for an order declaring that they have ceased to be investment companies. (Rel. IC-16072 - Oct. 23)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the Pacific Stock Exchange (SR-PSE-87-24) to eliminate all references in its rules to options on the PSE Technology Index because the trading of such options has been terminated. (Rel. 34-25052)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval of a proposed rule change by the New York Stock Exchange (SR-NYSE-87-37) that deletes, until May 1, 1988, restrictions that prohibit an approved person of a specialist member organization from acting as a managing underwriter for certain securities. UNION CARBIDE CORPORATION INC.

A notice has been issued giving interested persons until November 16 to request a hearing on an application by Union Carbide Corporation Inc., a New York corporation, under Section 310(b)(1)(ii) of the Trust Indenture Act of 1939. The application declares that the trusteeship of Manufacturers Hanover Trust under two Manufacturers indentures is not so likely to involve a material conflict of interest as to make it necessary in the public interest or for the protection of investors to disqualify Manufacturers from acting as trustee under each such indenture. ACQUISITIONS OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
