COMMISSION ANNOUNCEMENTS

COMMISSION CLOSED FOR HOLIDAY

On Monday, January 21, the Commission will be closed in recognition of Dr. Martin L. King, Jr.'s birthday, which is a Federal holiday. Publication of the Digest will resume on Tuesday, January 22.

ADMINISTRATIVE PROCEEDINGS

PROCEEDING AGAINST WILLIAM ROSZEL DISMISSED AND ROSZEL'S REGISTRATION CANCELLED

The Commission dismissed a public administrative proceeding that had been instituted on September 19, 1990 against William D. Roszel (Roszel), a registered investment adviser, and at the same time cancelled Roszel's registration. Before a hearing in the matter had commenced, the Commission was informed of Roszel's death. In light of this, the Commission deemed it appropriate to dismiss the proceedings and to cancel Roszel's registration. (Rel. IA-1267)

RICK MYERS INVESTMENT ADVISER REGISTRATION REVOKED

The decision of an administrative law judge revoking the registration of Rick Edward Myers, d/b/a Rick Edward Myers, CFP, an Ada, Michigan investment adviser, and barring him from association with any broker, dealer or investment adviser has become final. The law judge found that Myers had been convicted of mail fraud and permanently enjoined from violating registration and antifraud provisions of the securities acts. He also found that Myers failed to amend his application for investment adviser registration as required. (Rel. 34-28770)

INVESTMENT COMPANY ACT RELEASES

TEMPLETON FUNDS ANNUITY COMPANY

A notice has been issued giving interested persons until February 12, 1990 to request a hearing on an application by Templeton Funds Annuity Company and Templeton Immediate Variable Annuity Separate Account (Separate Account) for an order pursuant to Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 26(a)(2) and 27(c)(2) to the extent necessary to permit the deduction of mortality and expense risk charges from the assets of the Separate Account in connection with the issuance of certain individual immediate variable annuity contracts. (Rel. IC-17947 - January 16)

FALCON DIVERSIFIED HOLDINGS

A notice has been issued giving interested persons until February 15, 1991 to request a hearing on an application filed by Falcon Diversified Holdings, Inc., a registered open-end investment company, for an order declaring that it has ceased to be an investment company. (Rel. IC-17948 - January 16)

THE MUTUAL LIFE INSURANCE COMPANY OF NEW YORK

A notice has been issued giving interested persons until February 11, 1991 to request a hearing on an application filed by The Mutual Life Insurance Company of New York, MONY Variable Account A (Variable Account), and MONY Securities Corp. for an order pursuant to Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 26(a)(2) and 27(c)(2) of the Act to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Variable Account under certain variable annuity contracts. (Rel. IC-17953 - January 16)

NCC FUNDS

A notice has been issued giving interested persons until February 11, 1991 to request a hearing on an application filed by NCC Funds, et al. for a conditional order under Section 6(c) of the Investment Company Act that would exempt applicants from the provisions of Sections 18(f)(1), 18(g), and 18(i). Applicants seek relief to permit certain series of NCC Funds to issue and sell two classes of securities that would be identical in all respects except for differences related to shareholder services plan expenses, transfer agency expenses, exchange privileges and voting rights. HOLDING COMPANY ACT RELEASES

ENTERGY CORPORATION

A supplemental order has been issued authorizing Entergy Corporation, a registered holding company, to guarantee from January 1, 1991 through December 31, 2000 the lease

obligations of Entergy Services, Inc. (Services), its service subsidiary company, under a lease arrangement with Comdisco, Inc., a nonassociate company. The lease obligations concern a substantial portion of the computer equipment used by Services up to a maximum aggregate amount of \$17.2 million. (Rel. 35-25243)

MAINE YANKEE ATOMIC POWER COMPANY

An order has been issued authorizing Maine Yankee Atomic Power Company, an indirect nuclear electric generating subsidiary of Northeast Utilities and of New England Electric System, both registered holding companies, to issue and sell, from time to time through December 31, 1993, short-term notes and commercial paper (pursuant to an exception from competitive bidding) in an aggregate amount at any one time outstanding of \$21 million.

DELISTING GRANTED

An order has been issued granting the application of Ionics, Incorporated, Common Stock, \$1.00 Par Value, to strike from listing and registration on the <u>American Stock Exchange</u>. (Rel. 34-28791)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES

Proposed rule changes have been filed by the following under Rule 19b-4 of the Securities Exchange Act: Philadelphia Stock Exchange (SR-PHLX-90-39) to amend its parity and priority rules applicable to foreign currency options orders (Rel. 34-28775); American Stock Exchange (SR-AMEX-90-31) to amend Exchange Rules 131 and 154 to allow stop and stop limit orders in certain equity securities to be elected by a quotation (Rel. 34-28786); and National Association of Securities Dealers (SR-NASD-90-67) to amend Schedule H of the NASD By-Laws to eliminate the current price and volume thresholds so that the reporting requirements of that schedule will apply to each non-NASDAQ security traded by members. Additionally, the rule proposes to expand the definition of "non-NASDAQ security" to include securities listed on exchanges which do not meet primary exchange listing requirements and are not currently required to be reported. Finally, the proposed rule change would expand the definition of non-NASDAQ security to encompass over-the-counter trades effected in NASDAQ securities by market makers that are not registered NASDAQ market makers in such securities (Rel. 34-28788). Publication of the proposals is expected in the Federal Register during the week of January 21.

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the <u>New York Stock Exchange</u> (SR-NYSE-90-57) to increase, as of January 1, 1991, the monthly Trade Comparision fee that the Exchange charges to its members for options transactions from \$.0125 to \$.04 per contract-side has become effective under Rule 19b-4 of the Securities Exchange Act. (Rel. 34-28782)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed under Rule 19b-4 of the Securities Exchange Act by the <u>Pacific Stock Exchange</u> (SR-PSE-90-31) to amend its arbitration rules and procedures. (Rel. 34-28783)
