EXCHANGE COMMISSION

INTERPRETIVE LETTER

The Division of Corporation Finance has announced the publication of an interpretive letter interpreting Regulation S. The letter (Coral Gold Corporation, available February 19, 1991) involves a question regarding whether filing an offering circular for a foreign offering with the Commission under cover of Form 6-K, pursuant to Rule 13a-16(b) of the Securities Exchange Act, would constitute "directed selling efforts" for purposes of Rule 902(b) of Regulation S. Copies of the letter may be obtained through the Commission's Public Reference Room.

INVESTMENT COMPANY ACT RELEASES

VALUE LINE U.S. GOVERNMENT SECURITIES TRUST

A notice has been issued giving interested persons until March 20 to request a hearing on an application filed by the Value Line U.S. Government Securities Trust (Applicant) for an order under Section 8(f) of the Investment Company Act declaring that the Applicant has ceased to be an investment company as defined by the Act. MERRILL LYNCH SHORT-TERM GLOBAL INCOME FUND

A notice has been issued giving interested persons until March 20 to request a hearing on an application filed by Merrill Lynch Short-Term Global Income Fund, Inc., et al. for an order under Section 6(c) of the Investment Company Act. Applicants request an order to amend a prior order that granted an exemption from Sections 18(f), 18(g) and 18(i) to permit certain open-end investment companies to sell two classes of securities. The requested relief would permit such companies to sell their Class A shares subject to an account maintenance fee that would be paid to the distributor. (Rel. IC-18015 - February 22)

HOLDING COMPANY ACT RELEASES

NEW ENGLAND ELECTRIC SYSTEM

A supplemental order has been issued authorizing New England Electric System (NEES), a registered holding company, to extend its authority through December 31, 1993 to issue and sell up to 10,693,536 shares of its authorized but unissued common stock, \$1.00 par value per share, to the NEES Dividend Reinvestment Plan (Plan), such that, together with any other shares of common stock issued and sold under the Plan, the aggregate does not exceed 10,693,536 shares of common stock. In addition to the unissued shares of common stock, NEES may elect to purchase shares of its common stock on the open market and sell these shares to the Plan at the market price. (Rel. 35-25261)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGE

The <u>Chicago Board Options Exchange</u> filed a proposed rule change (SR-CBOE-91-06) to make more stringent the summary fine procedures imposed by the CBOE on members for failure to fulfill certain transaction reporting requirements. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 25. (Rel. 34-28907)

ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
