LIS SECURITIES AND EXCHANGE COMMISSION

INVESTMENT COMPANY ACT RELEASES

THOMSON FUND GROUP

A notice has been issued giving interested persons until March 25 to request a hearing on an application filed by the Thomson Fund Group for a conditional order under Section 6(c) of the Investment Company Act. The conditional order would exempt applicant from the provisions of Section 12(d)(3) of the Act and Rule 12d3-1 thereunder to the extent necessary to permit it to invest in equity or convertible debt securities issued by foreign issuers that derived more than 15% of their gross revenues from their activities as a broker, dealer, underwriter, or investment adviser, provided such investments meet the conditions described in proposed amended Rule 12d3-1. (Rel. IC-18017; International Series Rel. No. 234 - February 25)

LISTING, DELISTING AND UNLISTED TRADING ACTIONS

DELISTING GRANTED

An order has been issued granting the application of the <u>American Stock Exchange</u> to strike from listing and registration Hinderliter Industries, Inc., Common Stock, Par Value 1 cent. (Rel. 34-28917)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved a proposed rule change filed under Rule 19b-4 of the Securities Exchange Act by the <u>American Stock Exchange</u> (SR-AMEX-90-35) to increase the annual fee on listed company equity issues. The proposal increased the AMEX annual fee for stocks with separate categories based on the number of outstanding shares to a minimum fee of \$5,500 and a maximum fee of \$13,500. (Rel. 34-28908)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission granted accelerated approval to proposed rule changes filed under Rule 19b-4 of the Securities Exchange Act by the following: Philadelphia Stock Exchange (SR-PHLX-90-38) to allow the PHLX to list long-term equity and stock index options (Rel. 34-28910); and National Association of Securities Dealers (SR-NASD-91-8) to allow continued operation of the NASD-International Stock Exchange of the United Kingdom and the Republic of Ireland, Inc. Pilot Program. The Pilot Program permits an interchange of quotation information on about 740 securities without payment of a separate charge by market makers to receive such information (Rel. 34-28918). Publication of the proposals is expected in the Federal Register during the weeks of February 25 and March 4.

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

Proposed rule changes filed by the following have become immediately effective under Rule 19b-4 of the Securities Exchange Act: Chicago Board Options Exchange (SR-CBOE-91-03) to amend its transaction fees for customer, market-maker and member firm proprietary trading of stocks, bonds, rights, warrants and equity hybrid products (Rel. 34-28909); and Midwest Stock Exchange (SR-MSE-91-7) to amend the Exchange's fee schedule to waive Item Charge and Value Charge fees for firms routing orders in Tape B eligible securities to the MSE floor until December 31, 1991 (Rel. 34-28916).

APPROVAL OF PROPOSED RULE CHANGE AND AMENDMENT

The Commission has approved a proposed rule change and granted accelerated approval to an amendment to the proposed rule change filed under Rule 19b-4 of the Securities Exchange Act by the New York Stock Exchange (SR-NYSE-90-33) to allow the Exchange to make available to securities information vendors and "self-vending" member organizations and other financial institutions a specified portion of the limit orders for securities included on the Display Books (Look-at-the-Book Information).
