COMMISSION ANNOUNCEMENTS

SEC FILES PLAN IN DREXEL

On April 4, the Commission announced the filing of a plan of distribution of the Drexel civil disgorgement fund [SEC v. Drexel Burnham Lambert Inc., 88 Civ 6209, MP, SDNY]. This plan must be considered and approved by the District Court.

The civil disgorgement fund was established as part of the final judgment in SEC v. Drexel and is to be used to satisfy victims of Drexel's securities fraud in transactions by Drexel's High-Yield Bond Department. Drexel agreed to pay a total of \$350 million to the civil disgorgement fund and paid \$200 million at the time of the entry of the final judgment. Under a separate settlement agreement entered into between the Commission and the other parties to the bankruptcy, the balance of \$150 million will be paid in full into the civil disgorgement fund as part of a bankruptcy reorganization plan. TECHNICAL AMENDMENT

Form 4 is described at $\S249.104$. The text of the Form and its instructions do not, and the technical amendment will not, appear in the Code of Federal Regulations. The following note is added to Instruction 4(a)(i) of Form 4:

Note: The amount of securities beneficially owned at the end of the month specified in Column 5 of Table I and Column 9 of Table II should reflect those holdings reported or required to be reported by the date of the Form. Transactions and holdings eligible for deferred reporting on Form 5 need not be reflected in the month end total unless the transactions were reported earlier or are included on this Form.

ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST DAVID WILKS

The Philadelphia Regional Office announced that on March 26 the Commission instituted public administrative proceedings under Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 (Exchange Act) against David G. Wilks (Wilks). The Order for Proceedings alleges that from about 1984 through June 1989, Wilks violated Sections 5(a), 5(c) and 17(a) of the Securities Act of 1933, and Section 10(b) of the Exchange Act and Rule 10b-5 thereunder. Specifically, the Order alleges that Wilks sold unregistered securities through Executive Investments of Virginia, Inc. (Executive) and Virginia Carolina Financial Corp. (VCFC); defrauded Executive and VCFC clients; made false and misleading statements of material fact and omitted to state material facts concerning the use of the investment proceeds, the degree of risk involved in the investment; and the financial condition of Executive and VCFC. From June 1986 to August 1989 Wilks was a registered representative and general securities principal with Virginia-Carolina Securities, Inc., a broker-dealer formerly registered with the Commission. INVESTMENT COMPANY ACT RELEASES

MORTGAGE LIQUIDITY FUND

An order has been issued under Section 8(f) of the Investment Company Act declaring that Mortgage Liquidity Fund, Inc. has ceased to be an investment company. (Rel. IC-18078 - April 3)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES

Proposed rule changes have been filed by the following under Rule 19b-4 of the Securities Exchange Act: National Securities Clearing Corporation (SR-NSCC-90-24) to authorize enhancements to NSCC's CNS Reorganization Processing System (Rel. 34-29023; Boston Stock Exchange (SR-BSE-91-3) to amend its arbitration rules (Rel. 34-29034); and Cincinnati Stock Exchange (SR-CSE-91-02) to amend CSE Rules 11.9(c)(v) and 11.9(n)(1) relating to public agency order guarantees at the opening (Rel. 34-29036). Publication of the proposals was expected in the Federal Register during the week of April 1.

AMENDMENT TO PROPOSED RULE CHANGE

The American Stock Exchange has filed with the Commission a second amendment to a proposed rule change (SR-AMEX-90-28) under Rule 19b-4 concerning the AMEX's proposed rules governing the trading of Equity Index Participations. Specifically, among other things, the amendment provides that the liquidating index value applicable to exercises of the quarterly physical delivery privilege or an exercise of the cashout privilege on any trading day would be valued based on the next day's opening prices of component index stocks. Publication of the notice was expected in the Federal Register during the week of April 1. (Rel. 34-29032)

APPROVAL OF PROPOSED AMENDMENTS

The Commission has approved amendments to an options disclosure document filed by Trans Canada Options, Inc. under Rule 19b-4 of the Securities Exchange Act. The amendments reflect changes in the Canadian options market since the disclosure document was last amended in 1987. Publication of the approval order was expected in the <u>Federal Register</u> during the week of April 1. (Rel. 34-29033; International Series Rel. No. 250)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

The following proposed rule changes filed under Rule 19b-4 of the Securities Exchange Act have become effective immediately: Chicago Board Options Exchange (SR-CBOE-91-10) to amend its original listing fee for dually-listed warrants and other securities (hybrid) products (Rel. 34-29035); and Participants Trust Company (SR-PTC-91-03) to continue its Interim Program for PTC's March, 1991 settlement (Rel. 34-29038). Publication of the proposals is expected in the Federal Register during the week of April 8.

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the <u>Chicago Board Options Exchange</u> (SR-CBOE-91-06) to make more stringent the summary fine procedures imposed by the CBOE on members for failure to fulfill certain transaction reporting requirements. Publication of the order is expected in the <u>Federal Register</u> during the week of April 8. (Rel. 34-29037)
