ADMINISTRATIVE PROCEEDINGS

DECISION BARRING WALTER CURRAN FINAL

The decision of an administrative law judge barring Walter F. Curran of Morgantown, West Virginia from association with any broker or dealer has become final. Curran was formerly a sales representative of Dean Witter Reynolds, Inc. in Boston.

The law judge found that, in 1989, Curran was convicted, on the basis of his guilty plea, of obtaining money from investors on the basis of false representations. Instead of investing the money, Curran converted it to his personal use. The law judge further found that Curran was also convicted of violating federal currency reporting laws by knowingly transporting over \$130,000 into the United States from Canada and willfully failing to file the required report disclosing that fact.
