# ADMINISTRATIVE PROCEEDINGS

# PROCEEDINGS INSTITUTED AGAINST ERIC EMORY AND RENAISSANCE ADVISORS

The Commission instituted public proceedings against Eric Emory, president and a director of Renaissance Fund, Inc. (Fund), a closed-end investment company, and Renaissance Advisors, Inc., the Fund's investment adviser, of which Emory is president, a director and sole shareholder. Simultaneously, Respondents submitted Offers of Settlement wherein, without admitting or denying the findings, they consented to the Order.

The Order finds that Emory filed a registration statement and disseminated prospectuses and advertisements which were misleading in that they falsely promised exclusive investment in an index of securities and falsely described Fund dividends as tax advantaged. The Order also finds that Emory and the Adviser distributed misleading advertisements relating to their model portfolio and investment formula and that Emory distributed stale prospectuses for the Fund.

The Order further finds that Emory caused the Adviser to serve as the Fund's adviser without a written advisory contract, that Emory disseminated proxy solicitations with material omissions and that Emory aided and abetted several violations by the Fund. These violations consisted of failure to approve the terms of the advisory contract, undisclosed payment of dividends out of shareholder capital, sale of shares below net asset value, failure to approve auditors, lack of fidelity bond coverage, improper custody arrangements and haphazard recordkeeping. ### TEMPORARY APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved on a temporary basis a proposed rule change until July 31, 1992 extending the <u>Government Securities Clearing Corporation's</u> advance billing procedure. Publication of the proposal is expected in the <u>Federal Register</u> during the week of July 29. (Rel. 34-29479)

### APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved a proposed rule change (SR-DTC-91-13) filed by the <u>Depository Trust Company</u> that will allow DTC participants to deposit securities with specific ownership restrictions into a special segregation account at DTC. Publication of the proposal is expected in the <u>Federal Register</u> during the week of July 29. (Rel. 34-29481)

### IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

A proposed rule change (SR-CBOE-91-27) filed by the <u>Chicago Board Options Exchange</u> has become effective under Section 19(b)(3)(A) of the Securities Exchange Act. The proposal implements a three-month pilot program providing a rebate for certain Standard & Poor's 500 Index option transactions, together with a proposal to implement or increase the fees associated with new member orientation, the filing of FOCUS reports and electrical installation costs. Publication of the proposal is expected in the <u>Federal Register</u> during the week of July 29. (Rel. 34-29482)

A proposed rule change (SR-AMEX-91-17) filed by the <u>American Stock Exchange</u> has become effective under Section 19(b)(3)(A) of the Securities Exchange Act. The proposal provides a fifty percent discount in transaction charges for proprietary trades effected by members and member organizations in the securities of Canadian issuers trading on the Amex.
