INVESTMENT COMPANY ACT RELEASES

IDS MUTUAL INC.

A notice has been issued giving interested persons until September 6 to request a hearing on an application filed by IDS Mutual, Inc., twenty-seven other funds constituting the IDS Mutual Fund Group (Funds) and Shearson Lehman Brothers Inc. (Shearson). Applicants seek to amend a previous order issued by the Commission pursuant to Sections 6(c), 17(b) and 17(d) of the Investment Company Act and Rule 17d-1 thereunder. The amended order would permit the Funds to lend their portfolio securities to Shearson, an affiliate of the Funds' investment advisers, at rates no lower than those set forth on a schedule that is uniformly applied to all borrowers of the Funds' securities. The schedule is established and periodically revised by the Executive Committees of the Funds' Boards of Directors and ratified by the Boards, including a majority of the directors who are not interested persons of the Funds' investment advisers. HOLDING COMPANY ACT RELEASES

NEW ENGLAND ENERGY INCORPORATED

A notice has been issued giving interested persons until September 3 to request a hearing on a proposal by New England Energy Incorporated (New England Energy), a subsidiary of New England Electric System, a registered holding company. New England Energy proposes to extend through December 31, 1993, its existing authority to enter into interest rate protection agreements covering a total principal amount of up to \$200 million of its outstanding debt. GRANITE STATE ELECTRIC COMPANY

A notice has been issued giving interested persons until September 3 to request a hearing on a proposal by Granite State Electric Company, Massachusetts Electric Company, Narragansett Energy Resources Company (NERC), The Narragansett Electric Company, New England Electric Transmission Corporation, New England Energy Incorporated and New England Hydro Finance Company, Inc. (Hydro-Finance). The proposal is also being made by New England Hydro-Transmission Electric Company, Inc. (Mass Hydro), New England Hydro-Transmission Corporation (NH Hydro), New England Power

Company, New England Power Service Company and New England Electric System. All of these companies are each a direct or indirect subsidiary of New England Electric System (NEES), a registered holding company, which is also one of the Applicants. The Applicants seek authorization for NERC and Hydro Finance to participate as lenders in the NEES Money Pool (Money Pool). Authorization is also sought for NH Hydro and Mass Hydro to borrow up to a maximum amount of \$25 million from the Money Pool. The Applicants further propose to divide the Money Pool borrowers into two groups having different priorities with regard to their Money Pool borrowings. (Rel. 35-29359)

JERSEY CENTRAL POWER AND LIGHT COMPANY

A notice has been issued giving interested persons until September 3 to request a hearing on a proposal by Jersey Central Power and Light Company, Metropolitan Edison Company, and Pennsylvania Electric Company (Utilities). The Utilities are electric public utility subsidiaries of General Public Utilities Corporation (GPU), a registered holding company, and GPU Service Corporation (Service), a service company subsidiary of GPU. The Utilities propose to lease to non-affiliated companies (Lessees) up to 50% of the capacity of a fiber optic communications system (Fiber Optic System) consisting, initially, of a cable containing up to 36 fibers. The Fiber Optic System will be built and owned by the Utilities and operated and maintained by Service. Service proposes to perform Fiber Optic System related maintenance services for the Lessees. (Rel. 35-29359)

NATIONAL FUEL GAS COMPANY

A notice has been issued giving interested persons until September 3 to request a hearing on a proposal by National Fuel Gas Company (National), a registered holding company, and its wholly owned subsidiary companies. These subsidiary companies are National Fuel Gas Distribution Corporation (Distribution), Penn-York Energy Corporation (Penn-York), National Fuel Gas Supply Corporation (Supply) and Seneca Resources Corporation (Seneca) (Subsidiaries). National proposes to issue and sell in one or more transactions through December 31, 1993, up to an aggregate principal amount of \$200 million in any combination of (a) debentures and/or (b) medium-term notes. In addition, National proposes to use the proceeds from the financing to lend to its Subsidiaries in exchange for unsecured notes up to (a) \$150 million to Distribution, (b) \$100 million to Penn-York, (c) \$100 million to Supply, and (d) \$50 million to Seneca. LTV STEEL MINING CO.

An order has been issued under Section 2(a)(3) of the Public Utility Holding Company Act declaring that LTV Steel Mining Co., a limited partnership principally engaged in mining, beneficiating and selling iron ore pellets to its parent LTV Steel Company, Inc., is not an "electric utility company." (Rel. 35-29360)

SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval for a temporary period ending on May 24, 1993, to a proposed rule change filed by the <u>Pacific Stock Exchange</u> (SR-PSE-91-28) to amend several Exchange Rules relating to primary market protection of limit orders. (Rel. 34-29543)

PROPOSED RULE CHANGE

The <u>American Stock Exchange</u> filed a proposed rule change (SR-AMEX-91-16) under Rule 19b-4 to adopt Section 146 of the Amex <u>Company Guide</u> to allow the Amex to reduce or waive the amount of original, annual, and/or additional listing fees under certain limited circumstances to accommodate unique situations. Publication of the proposal is expected in the <u>Federal Register</u> during the week of August 12. (Rel. 34-29544)
