INVESTMENT COMPANY ACT RELEASES

VARIABLE ANNUITY LIFE INSURANCE COMPANY

A notice has been issued giving interested persons until September 18 to request a hearing on an application by the Variable Annuity Life Insurance Company, the Variable Annuity Life Insurance Company Separate Account A and American General Life Insurance Company of New York. The application was also made by American General Life Insurance Company of New York Separate Account E, American General Life Insurance Company of Delaware and American General Life Insurance Company of Delaware Separate Account D (collectively, Substitution Applicants). Substitution Applicants request a Commission order under Section 26(b) of the Investment Company Act. The order would approve the substitution of shares of the American General Series Portfolio Company (AGSPC) and the American Life Investment Trust (LIT Fund) for shares of the American General Equity Accumulation Fund, Inc., American General Fixed-Income Accumulation Fund, Inc., and American General Money Market Accumulation Fund, Inc. (collectively, ACAM Funds). In addition, Substitution Applicants, AGSPC, the LIT Fund and the ACAM Funds request an order under Section 17(b) or under Section 6(c) of the Act granting exemptions from the provisions of Section 17(a) of the Act to the extent necessary to permit certain purchase and sale transactions between affiliates in connection with the substitutions.
