RULES AND RELATED MATTERS

ACCEPTANCE OF SIGNATURE GUARANTEES FROM ELIGIBLE GUARANTOR INSTITUTIONS

The Commission is publishing for comment new Rule 17Ad-15 under the Securities Exchange Act of 1934 (Act). The proposed rule would implement Section 17A(d)(5) of the Act, as amended by Section 206 of the Securities Enforcement Remedies and Penny Stock Reform Act of 1990. The proposed rule, if adopted, would prohibit inequitable treatment of eligible guarantor institutions and would require transfer agents to establish written standards for the acceptance of signature guarantees. Publication of the proposed rule is expected to be made in the <u>Federal Register</u> during the week of September 16. (Rel. 34-29663; File No. S7-27-91)

CHAIRMAN BREEDEN TO TESTIFY

ADMINISTRATIVE PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS AGAINST EDWARD ANCHEL

The Commission announced the institution of administrative proceedings pursuant to Rule 2(e) of the Commission's Rules of Practice against Edward Anchel (Anchel), an accountant. The Commission accepted Anchel's offer of settlement to be denied the privilege of appearing or practicing before the Commission with a right to resume practicing or appearing in four years upon a showing of having met certain conditions. PROCEEDINGS INSTITUTED AGAINST RICHARD AVON

The Commission instituted public administrative proceedings under the Securities Exchange Act of 1934 against Richard C. Avon (Avon), a former registered representative of Amerimutual Corporation (Amerimutual). Amerimutual was registered with the Commission as a broker-dealer from October 12, 1984 until February 12, 1990. Amerimutual ceased operations in about March 1989. During 1986 to 1989, Amerimutual acted as the underwriter and principal market-marker for several blind pool offerings including Guiness Capital Funding, Inc. (Guiness) and Delta Venture Funds, Inc. (Delta). The Order for Proceedings alleges that Avon willfully violated and aided and abetted violations by Amerimutual of the antifraud provisions of the federal securities laws by employing fraudulent sales practices and schemes which artificially created and supported the markets for Guiness and Delta securities.

A hearing will be scheduled to determined whether the allegations against Avon are true, and, if so, what, if any, remedial actions are appropriate. (Rel. 34-29644)

INVESTMENT COMPANY ACT RELEASES

IDS MUTUAL INC.

A conditional order has been issued under Sections 6(c), 17(b) and 17(d) of the Investment Company Act and Rule 17d-1 thereunder on an application filed by IDS Mutual, Inc. and twenty-seven other funds constituting the IDS Mutual Fund Group (the Funds), and Shearson Lehman Brothers Inc. (Shearson). The order amends a prior Commission order so that the Funds may lend their securities to Shearson and certain affiliates of Shearson at rates no lower than those set forth on a schedule that is uniformly applied to all borrowers of the Funds' securities. The schedule is established and periodically revised by the Executive Committees of the Funds' Boards of Directors and ratified by the Boards, including a majority of the directors who are not interested persons of the Funds' investment advisers. The rates set forth on the schedule will be used instead of the minimum rates specified in one of the conditions to the prior order. (Rel. IC-18299 -September 9)

SELF-REGULATORY ORGANIZATIONS

PROPOSED REGISTRATION

The MBS Clearing Corporation has filed a proposed registration under Section 19(b) of the Securities Exchange Act. The proposal provides for a one-year extension to September 30, 1992 of MBSCC's temporary registration as a clearing agency. Publication of the notice is expected in the <u>Federal Register</u> during the week of September 9. (Rel. 34-29657)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change filed by the <u>Philadelphia Stock Exchange</u> (SR-PHLX-91-31) pursuant to Rule 19b-4. The rule change will increase, strictly for options on Duracell International, Inc. common stock, the size of public customer orders eligible for automatic execution through Auto-X, the Exchange's automatic execution system for options, from 10 to 20 contracts. Publication of the order is expected in the <u>Federal Register</u> during the week of September 9. (Rel. 34-29662)
