U.S. SECURITIES EXCHANGE COMMISSION September 13, 1991

RICHARD WALKER APPOINTED REGIONAL ADMINISTRATOR OF THE COMMISSION'S NEW YORK REGIONAL OFFICE

PUBLICATION OF REGULATORY FLEXIBILITY AGENDA AND RULES SCHEDULED FOR REVIEW

The Commission today authorized the publication of its Regulatory Flexibility Agenda and Rules scheduled for review in the October 1991 edition of the Unified Agenda of Federal Regulations. This publication lists the rulemaking actions, including rule reviews, which the Commission anticipates considering in the next six to twelve months. ADMINISTRATIVE PROCEEDINGS

DECISION BARRING ROBERT GLEAVE FINAL

The decision of an administrative law judge barring Robert C. Gleave of Aurora, Colorado from association with any broker or dealer has become final. Gleave was formerly a vice-president of Excel Securities, Inc., an Englewood, Colorado brokerage firm.

The law judge found that in 1988 Gleave was a principal conspirator in a fraudulent scheme to list the worthless stock of Protecto Industries, Inc. in the pink sheets and manipulate its price. The law judge also found that Gleave violated registration provisions in connection with the offer and sale of that stock and that he was convicted in 1989, on the basis of his guilty plea, of securities fraud and conspiracy to commit securities fraud, wire fraud and bank fraud. Finally, the law judge found that he was enjoined in 1990, with his consent, from violations of registration and antifraud provisions of the securities acts. (Rel. 34-29656)
