EXCHANGE COMMISSION COMMISSION ANNOUNCEMENTS

SEC AND CFTC APPROVE EXPANDED CROSS-MARGIN PROGRAMS

The U.S. Securities and Exchange Commission and the Commodity Futures Trading Commission concurrently have approved proposed rule changes by The Options Clearing Corporation (OCC) and the Chicago Mercantile Exchange (CME) that are intended to improve coordination in the clearance and settlement of options, futures and futures options. More specifically, the proposals, as approved, will expand the existing cross-margin program between the two organizations to permit clearing members to include intermarket futures and options positions they hold for participating market makers, specialists, registered traders and CME members (market professionals). This non-proprietary cross-margin program will permit OCC and CME to offer beneficial margin treatment to clearing members that hold combined futures and options positions and that are members of both organizations or have affiliates that are members of the other organization. ## CIVIL PROCEEDINGS

CIVIL INJUNCTIVE ACTION AND MOTION FOR TEMPORARY RESTRAINING ORDER AND OTHER RELIEF AGAINST ARTHUR NUGENT III, ET AL.

The Commission announced that on November 25 it filed a civil injunctive action against Arthur F. Nugent III, A.F. Nugent & Company, Specialized Commercial Maintenance, Inc. and SCM, Inc. The Commission also filed a Motion for a Temporary Restraining Order and Other Relief in the U.S. District Court for the Eastern District of Michigan, Southern Region. On the same day, the Court entered an order freezing defendants' assets and preventing destruction of documents.

According to the complaint, defendant Arthur F. Nugent III (Nugent), 28, is a resident of Shelby Township, Michigan and the corporate defendants are entities through which Nugent conducts his business. The complaint alleges that Nugent falsely held himself out to potential investors as a registered investment adviser and manager of a mutual fund and solicited investors to invest money with him by making materially false and misleading statements. According to the complaint, investors have entrusted Nugent with at least \$250,000. Nugent told investors that he bought securities and commodities on their behalf, but the Commission alleges that, in reality, he converted client funds to his own use. [SEC v. Arthur F. # INVESTMENT COMPANY ACT RELEASES

## PANTHER PARTNERS, L.P.

A notice has been issued giving interested persons until December 19 to request a hearing on an application filed by Panther Partners, L.P., for an order under Section 6(c) of the Investment Company Act. The order would exempt applicant from the provisions of Section 12(d)(3) of the Act and Rule 12d3-1 thereunder. Applicant would be exempted to the extent necessary to permit it to acquire securities of foreign issuers engaged in securities-related activities in accordance with the conditions of proposed amendments to Rule 12d3-1 under the Act. #### AMERICAN GENERAL LIFE INSURANCE COMPANY OF DELAWARE

A notice has been issued giving interested persons until December 18 to request a hearing on an application filed by American General Life Insurance Company of Delaware, American General Life Insurance Company of Delaware Separate Account D (Separate Account D) and American General Securities Incorporated. The application is for an order pursuant to Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act. Applicant would be exempted to the extent necessary to permit the deduction of mortality and expense risk charges from the assets of Separate Account D. (Rel. IC-18417 - November 22)

### KEMPER INVESTORS LIFE INSURANCE COMPANY

A notice has been issued giving interested persons until December 17 to request a hearing on an application filed by Kemper Investors Life Insurance Company, Kilico Variable Annuity Separate Account (Variable Account) and Kemper Financial Services, Inc. for an order pursuant to Section 6(c) of the Investment Company Act. The order would grant exemptions from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act to the extent necessary to permit the deduction of mortality and expense risk charges from the assets of the Variable Account under certain group variable and market value adjusted deferred annuity contracts. Subsidiaries and Service propose to use the proceeds from the Notes to repay debt and for other corporate purposes. (Rel. 35-25413)

OCEAN STATE POWER, ET AL.

A notice has been issued giving interested persons until December 16 to request a hearing on a proposal by Ocean State Power (OSP) and Ocean State Power II (OSP II), electric utility subsidiaries of both Eastern Utilities Associates and New England Electric System, registered holding companies. OSP and OSP II propose to refinance approximately \$225 million of term debt, either directly or through a newly created finance subsidiary, and establish an approximately \$30 million line of credit. NATIONAL FUEL GAS COMPANY, ET AL.

The aggregate principal amount of such Commercial Paper and Notes shall not exceed \$350 million outstanding at any one time. (Rel. 35-25413)

# CENTRAL AND SOUTH WEST CORPORATION, ET AL.

A notice has been issued giving interested persons until December 16 to request a hearing on a proposal by Central and South West Corporation (CSW), a registered public-utility holding company, and its nonutility subsidiary company, Transok, Inc.
