# ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST ERNEST MICHAUD AND BRANDON SECURITIES & INVESTMENTS, INC.

The Commission ordered that public administrative proceedings be instituted under the Securities Exchange Act and the Investment Advisers Act against Ernest E Michaud (Michaud) of Wakefield, Rhode Island and Brandon Securities & Investments, Inc. (BSI) Michaud was doing business in the name of Brandon Associates, and was the sole owner of BSI, a registered broker-dealer and investment adviser, and Brandon Securities, Inc., a registered commodities broker.

The order instituting proceedings alleges that Michaud was convicted, following a guilty plea, of one count of securities fraud in violation of Section 10(b) of the Securities Exchange Act and Rule 10b-5 promulgated thereunder for defrauding investors of approximately \$1.4 million through material misrepresentations and omissions concerning the use of investors' funds, the status of investors' accounts and the profitability of their investments. That conviction provides a basis for the Commission to institute administrative proceeding to determine whether sanctions against Michaud and BSI are in the public interest.

The case was initially investigated by the Federal Bureau of Investigation, the National Association of Securities Dealers, the Rhode Island Securities Division and the Boston Regional Office of the Commission. (Rel. 34-29968)

# ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission approved on an accelerated basis proposed rule changes filed by the Options Clearing Corporation (SR-OCC-91-18) and the Intermarket Clearing Corporation (SR-ICC-91-01). The OCC and ICC proposals relate to the inclusion of an alternative minimum additional margin requirement into their margining systems. Publication of the order expected in the Federal Register during the week of December 2. (Rel. 34-29990)

The Commission has approved a proposed rule change filed by the Options Clearing Corporation (SR-OCC-90-01) to expand the Options Clearing Corporation/Chicago Mercantile Exchange cross-margin program to include futures and options positions held by Clearing Members for certain market professionals. Publication of the order is expected in the Federal Register during the week of December 2. (Rel. 34-29991)

Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
