COMMISSION ANNOUNCEMENTS

OMISSION OF LITIGATION RELEASE NUMBERS IN SEC NEWS DIGEST FOR DECEMBER 20, 1991

The litigation release numbers were inadvertently left off in last Friday's SEC News Digest for five civil action releases. The respective litigation release numbers are as follows: Alpine Mutual Fund Trust - (LR-13124); Carl W. Martin - (LR-13126); Strategic Management, Inc. - (LR-13125); Lon Williams and Steve Sanders - (LR-13124); and James H. Guerin - (LR-13122).

ADMINISTRATIVE PROCEEDINGS

NASD ACTION AGAINST WILLIAM WUERCH AND MARK THOMASON AFFIRMED

The Commission has affirmed disciplinary action taken by the NASD against William F. Wuerch of Mercer Island, Washington and Mark D. Thomason of Kirkland, Washington, both of whom were associated with National Securities Corporation, an NASD member The NASD censured respondents, barred them from association with any member in a principal capacity, suspended Thomason from any such association for 30 days and required Thomason to requalify by examination for any capacity in which he seeks to become registered. Wuerch was fined \$25,000 and Thomason was fined \$5,000.

During the period July through September 1986, Wuerch and Thomason co-managed National's Bellevue, Washington branch office. The Commission affirmed NASD findings that respondents failed to give National required notification of the branch office's sale to customers of \$330,000 worth of promissory notes issued by Bright Blocks, Inc., doing business as U.S. Associates, Inc. (Rel. 34-30083)

CIVIL PROCEEDINGS

STEVEN WYMER ARRESTED, DENIED BAIL

The U.S. Attorney's Office for the Central District of California and the Securities and Exchange Commission announced that Steven D. Wymer was arrested and charged with one count of securities fraud and two counts of mail fraud. On December 19, following his arrest, Wymer was denied bail and ordered to federal custody. The Court found that Wymer was a flight risk and an economic danger to the community, in light of his

failure to explain or produce evidence to the Commission staff with respect to the disposition of some \$100 million in funds belonging to advisory clients of Institutional Treasury Management Inc. On December 11, Wymer, ITM and Denman & Company were temporarily enjoined, a receiver was appointed over ITM and Denman, and the defendants' assets were frozen. [SEC v. STEVEN WYMER, INSTITUTIONAL TREASURY MANAGEMENT AND DENMAN & COMPANY PRELIMINARILY ENJOINED, ASSET FREEZE MODIFIED

On December 20, the Honorable Richard A. Gadbois, Jr. of the U.S. District Court of the Central District of California entered preliminary injunctions against defendants Steven D. Wymer, Institutional Treasury Management Inc. and Denman & Company and modified the asset freeze imposed by the Court on December 11, 1991. The Court accepted the recommendation of the Receiver and lifted the asset freeze with respect to the majority of the \$1.2 billion in TEM client accounts. The Court ordered that the asset freeze on ITM's corporate assets and on Wymer's personal assets be continued, to preserve a source for potential disgorgement and penalties. The Receiver's interim report filed with the Court indicates that losses to clients' accounts are now known to be approximately \$100 million. [SEC v. CIVIL ACTIONS AGAINST THOMAS ROBERTS AND WILLIAM ROBERTS

The Commission announced the filing today of a complaint in the U.S. District Court for the Southern District of Texas against Thomas J. Roberts (Thomas Roberts), formerly a Senior Financial Analyst at Vista Chemical Company (Vista), and William Roberts, Thomas Roberts' brother, in connection with their trading in the securities The complaint alleges that, while in possession of material nonpublic information concerning the sale of Vista, Thomas Roberts purchased Vista stock and tipped his brother, William Roberts. The complaint further alleges that during the period May 1990 and continuing thereafter, Thomas Roberts also communicated material, nonpublic information concerning the sale of Vista to Edward L. Ruggiero ("Ruggiero"), a co-worker at Vista and against whom the Commission has previously brought a civil action. The complaint alleges that Ruggiero tipped his friend, Christopher L. Parker, who also bought Vista call options for himself, and tipped his brother. Simultaneously with the filing of the complaint, Thomas and William Roberts each consented, without admitting or denying any of the allegations in the Complaint, to entry of a Final Judgment against them permanently restraining and enjoining them from violating of Sections 10(b) and 14(e) of Exchange Act and Rules 10b-5 and 14e-3 promulgated thereunder, requiring them to disgorge \$10,126.58 and \$38,565.25, respectively, and requiring Thomas Roberts to pay an ITSA penalty in the amount of \$10,126.58. DR EQUITY FUND

An order had been issued under Section 8(f) of the Investment Company Act declaring that DR Equity Fund has ceased to be an investment company. (Rel. IC-18449 - December 17)

PATHFINDER HERITAGE FUNDS

An order has been issued under Section 8(f) of the Investment Company Act declaring that Pathfinder Heritage Funds has ceased to be an investment company. (Rel. IC-18450 - December 18)

KEMPER INVESTORS LIFE INSURANCE COMPANY, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting Kemper Investors Life Insurance Company, KILICO Variable Annuity Separate Account (Variable Account), and Kemper Financial Services, Inc. from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the 1940 Act to the extent necessary to permit the deduction of mortality and expense risk charges from the assets of the Variable Account under certain group variable and market value adjusted deferred annuity contracts. (Rel. IC-18451 - December 19)

PANTHER PARTNERS, L.P.

An order has been issued on an application filed by Panther Partners, L.P. under Section 6(c) of the Investment Company Act exempting it from the provisions of Section 12(d)(3) of the Act and Rule 12d3-1 thereunder to the extent necessary to permit it to acquire securities of certain foreign issuers engaged in securities-related activities in accordance with the conditions of proposed amendments to Rule 12d3-1 under the Act. (Rel. IC-18452; International Series Rel. 355 - December 20)

HOLDING COMPANY ACT RELEASES

OHIO POWER COMPANY

An order has been issued authorizing Ohio Power Company, an electric public-utility subsidiary company of American Electric Power Company, Inc., a registered holding company, to sell a portion of its electric power distribution poles to Alltel Ohio, Inc. and The Western Reserve Telephone Company. (Rel. 35-25431)

MISSISSIPPI POWER & LIGHT COMPANY

An order has been issued authorizing a proposal by Mississippi Power & Light Company, a public-utility subsidiary company of Entergy Corporation, a registered holding company. MP&L proposes, from January 1, 1992 through December 31, 1993, to acquire,

in whole or in part, one or more series of MP&L's outstanding first mortgage bonds, general and refunding mortgage bonds, preferred stock, and/or pollution control revenue bonds. Jurisdiction has been reserved over the proposal, from January 1, 1992 through December 31, 1993, to issue and sell up to \$150 million aggregate principal amount of one or more new series of general and refunding mortgage bonds and/or up to \$37.5 million aggregate par value of preferred stock, cumulative, \$100 par value, in one or more new series. This jurisdiction is also reserved over the proposal to amend its Restated Articles of Incorporation, as amended, to establish a new class of preferred stock having no par value or a nominal par value. and to enter into arrangements for the issuance and sale of up to \$25 million of tax-exempt bonds, in one or more series. EASTERN UTILITIES ASSOCIATES

A supplemental order has been issued extending the authorization of Eastern Utilities Associates, a registered holding company, to make capital contributions to its wholly owned electric utility subsidiary, Newport Electric Corporation, through December 31, 1993. (Rel. 35-25433)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-CBOE-91-46) filed by the <u>Chicago Board Options Exchange</u> which establishes a \$10 per month fee to be charged to active clearing firms has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the <u>Federal Register</u> during the week of December 23. (Rel. 34-30088)

FILING OF AMENDMENT NO. 1 TO A PROPOSED RULE CHANGE

Pursuant to Rule 19b-4, the <u>American Stock Exchange</u> has filed with the Commission an amendment to a proposed rule change regarding options on the S&P MidCap 400 Index. The amendment provides among other things, that the Index value for purposes of settling Index options will be calculated on the basis of the opening market prices of component stocks on the business day prior to the expiration date of such options. Publication of the proposal is expected in the <u>Federal Register</u> during the week of December 23. (Rel. 34-30095)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Options Clearing Corporation filed a proposed rule change (SR-OCC-91-20) to rescind Amendment No. 5 to the Stockholders Agreement. Amendment No. 5 provided that in the event of a sale or liquidation of OCC, OCC's stockholders would pay over a portion of the after-tax proceeds to Clearing Members. Publication of the proposal is expected in the <u>Federal Register</u> during the week of December 23. (Rel. 34-30101)

PROPOSED RULE CHANGE

The <u>Depository Trust Company</u> filed with the Commission a proposed rule change (SR-DTC-91-23) that would eliminate most urgent withdrawals of corporate issues settling in same-day funds. Publication of the proposal is expected in the <u>Federal Register</u> during the week of December 23. (Rel. 34-30104)
