#### COMMISSION ANNOUNCEMENTS

#### BRANDON BECKER TO TESTIFY

Brandon Becker will testify tomorrow, June 22, before the House Subcommittee on Telecommunications and Finance at 1:00 p.m. in Room 2322 of the Rayburn House Office Building regarding the Market 2000 Report and the Unlisted Trading Privileges Act of 1934 (HR 4535).

#### ENFORCEMENT PROCEEDINGS

## ADMINISTRATIVE PROCEEDINGS INITIATED AGAINST SAN MARINO SECURITIES

An order instituting public administrative proceedings pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 has been issued with respect to San Marino Securities, Inc., a Salt Lake City broker-dealer (San Marino). The proceedings were instituted to determine what, if any, remedial action should be taken against San Marino based upon alleged violations of Sections 15(b), 15(c) and 17(a) of the Exchange act and Rules 15b3-1, 15c3-1 and 17a-3 promulgated pursuant to the Exchange Act.

The Order alleges that San Marino failed to comply with an October 3, 1990, order by the federal district court for the District of Utah which ordered San Marino to offer rescission to certain customers who were sold securities in violation of Rule 15c2-6 promulgated under the Exchange Act of 1934. The Order also alleges that San Marino failed to reflect the liability associated with compliance with the Court's Order on its financial statements or in its net capital computations. Further the Order alleges that San Marino failed to amend its application to become a broker-dealer to reflect that it self-cleared a number of customer transactions. Finally, San Marino failed to comply with the Commission's net capital requirements as of May 31, 1991 and June 28, 1991. (Rel. 34-34208)

# INVESTMENT COMPANY ACT RELEASES

#### MCDONALD TAX EXEMPT MONEY MARKET FUND, INC.

An order has been issued under Section 8(f) of the Investment Company Act declaring that McDonald Tax Exempt Money Market Fund, Inc. has ceased to be an investment company. (Rel. IC-20363 - June 20)

# THE MALAYSIA FUND, INC., ET AL.

A notice has been issued giving interested persons until July 18 to request a hearing on an application filed by The Malaysia Fund, Inc., et al. for an exemption under Section 6(c) of the Investment Company Act from Sections 13(a)(2), 18(a), 18(c), and 23(a) and under Section 17(d) and Rule 17d-1 thereunder. Applicants seek an order to permit them to enter into deferred fee arrangements with certain of their directors. (Rel. IC-20364 - June 20)

## HOLDING COMPANY ACT RELEASES

## PP&L RESOURCES, INC.

A notice has been issued giving interested persons until July 11 to request a hearing on an application by PP&L Resources, Inc. (Resources) for an order approving the direct acquisition by Resources, under Sections 9(a)(2) and 10 of the Public Utility Holding Company Act, of all the outstanding shares of common stock of Pennsylvania Power & Light Company (PP&L), a Pennsylvania corporation, and, through such acquisition, the indirect acquisition of 33.3% of the outstanding shares of Safe Harbor Water Power Corporation (Safe Harbor), also a Pennsylvania corporation. The order is also sought to grant Resources and its subsidiary companies, upon consummation of the proposed transaction, an exemption under Section 3(a)(1) of the Act from all provisions of the Act, except Section 9(a)(2). # CENTRAL AND SOUTH WEST CORP., ET AL.

A supplemental notice has been issued giving interested persons until July 11 to request a hearing on a proposal by Central and South West Corporation (CSW), a registered holding company, and its nonutility subsidiaries, CSW Energy, Inc. (Energy), CSW Development-I, Inc. (Energy Sub) and CSW Orange, Inc. (CSWO), ARK/CSW Development Partnership (Joint Venture), Orange Cogeneration Limited Partnership (Project Venture), and Orange Cogeneration G.P., Inc. (JV Sub) (collectively, Applicants) for Energy Sub and Joint Venture to organize two new special purpose wholly

owned subsidiaries under Delaware law, CSW Orange II, Inc. (Orange LP) and Orange Cogeneration GP II, Inc. (Orange GP), respectively; for Energy Sub and Joint Venture to assign to Orange LP and Orange GP the right, title and interests in and to CSWO and JV Sub, respectively; for the Applicants to make capital contributions, open account advances and intercompany loans to Orange LP and Orange GP and for Orange LP and Orange GP to make capital contributions, open account advances and intercompany loans downstream to Project Venture; and for Orange LP and Orange GP to pledge the stock of CSWO and JV Sub as collateral under a credit agreement. #### CENTRAL AND SOUTH WEST CORP., ET AL.

A notice has been issued giving interested persons until July 11 to request a hearing on a proposal by Central and South West Corporation (CSW), a registered holding company, and its nonutility subsidiary company, CSW Energy, Inc. (Energy), to enter into a joint venture (Joint Venture) with Pentech Energy, Inc., a Delaware corporation, for the development of generating facilities, including independent power projects within CSW's service territory, qualifying facilities (QF) under the Public Utility Regulatory Policies Act of 1978, and exempt wholesale generators (EWG) under Section 32(e) of the Act. Venture has specific plans to develop an energy facility in Ohio, that would be a QF or an EWG, through a limited partnership (Project Partnership). CSW and CSW Energy seek to make investments of up to \$15 million in the Joint Venture. CSW and CSW Energy also seek to acquire an interest in, and make advances to, Project Partnership. investments, whether in the form of equity contributions, loans, development payments, or otherwise, will be included in the aggregate investment authority of \$15 million. ## IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the <u>Chicago Board Options Exchange</u> to amend Rule 1 of Article 1 of the Exchange's Rules (SR-CHX-94-13) has become effective upon filing. Publication of the proposal is expected in the Federal Register during the week of June 20. (Rel. 34-34223)

#### APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change (SR-NYSE-94-05) filed by the <u>New York Stock Exchange</u> relating to additions to the "List of Exchange Rule Violations and Fines Applicable Thereto Pursuant to Rule 476A." (Rel. 34-34230)

The Commission approved a proposed rule change (SR-NYSE-90-10) filed by the New York Stock Exchange relating to various rule revisions recommended by the Market Regulation Review Committee of the NYSE. (Rel. 34-34231)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE AND APPROVAL OF AMENDMENT THERETO

The Philadelphia Stock Exchange filed a proposed rule change (SR-Phlx-94-26) and Amendment No. 1 thereto, relating to the listing of long-term options, and the listing of \$25.00 strike price intervals for farterm options series, on the Big Cap Index. The Commission granted accelerated approval of the proposed rule change and Amendment No 1. Publication of the notice is expected in the <u>Federal Register</u> during the week of June 20. APPROVAL OF PROPOSED RULE CHANGE AND ACCELERATED APPROVAL OF AMENDMENTS THERETO

The Commission approved a proposed rule change filed by the <u>Philadelphia Stock Exchange</u> (SR-Phlx-93-45) and granted accelerated approval of Amendment Nos. 2, 3, 4 and 5 to the proposed rule change relating to quarterly index expiration options on all stock indexes for which index options are listed for trading by the Phlx. Publication of the notice and order is expected in the <u>Federal Register</u> during the week of June 20. (Rel. 34-34234)
