COMMISSION ANNOUNCEMENTS

EXTENSION OF COMMENT PERIOD

The Commission is extending the comment period to July 15, 1994 for proposed amendments to Rule 10b-10 and proposed Rule 15c2-13 under the Securities Exchange Act of 1934. These proposals were first published for comment on March 9, 1994 and would require brokers, dealers and municipal securities dealers to disclose certain information on a customer confirmation. OPEN MEETING - WEDNESDAY, JUNE 29, 1994 - 10:00 A.M.

The subject matter of the June 29 open meeting will be:

The Commission will consider whether to approve a proposed rule change by the National Association of Securities Dealers adopting a short sale bid-test for Nasdaq National Market securities. The proposal would prohibit short sales at or below the current inside bid as shown on the Nasdaq screen when that bid is lower than the previous inside bid. The proposal contains certain exemptions, including an eighteen-month exemption for qualified Nasdaq market makers, options market makers, and warrant market makers. ENFORCEMENT PROCEEDINGS

SETTLEMENT REACHED WITH DEFENDANT IN INSIDER TRADING CASE

The Commission announced that on June 22 the Honorable Jay C. Waldman, District Judge, United States District Court for the Eastern District of Pennsylvania, signed a Final Order As To R. James Macaleer By Consent, in connection with alleged illegal trading in the securities of Shared Medical Systems Corporation (SMS) by R. James Macaleer (Macaleer), the Chairman and Chief Executive Officer of SMS, while in possession of material, nonpublic information concerning the projected financial performance of SMS.

The Commission alleged, and Macaleer admitted, that shortly before December 15, 1986, Macaleer received material, nonpublic information concerning SMS' business prospects for 1987. Shortly after receiving this material, nonpublic information, during the period December 22, 1986 through December 31, 1986, Macaleer sold 100,000 shares of SMS stock, and caused the sale of an additional 22,050 shares of SMS stock

in accounts held for the benefit of his children. Within two days following the announcement of the information Macaleer possessed, SMS' stock price dropped 26%. As a result of making the sales of SMS stock, Macaleer avoided losses that he and his children otherwise would have incurred.

Macaleer admitted allegations by the Commission that he violated Section 17(a)(3) of the Securities Act of 1933 (Securities Act) in connection with the insider trading in the stock of SMS, and agreed to pay disgorgement in the sum of \$99,500, and prejudgment interest of \$100,495 in settlement of the Commission's claim.

As part of the settlement of the lawsuit, the Commission dismissed other charges that Macaleer violated other sections of the antifraud provisions of the federal securities laws. [SEC v. Shared Medical Systems Corporation, et al., 91-CV-6546] (LR-14130)

INVESTMENT COMPANY ACT RELEASES

CENTENNIAL APPRECIATION PORTFOLIO, SERIES 1 AND 2

A notice has been issued giving interested persons until July 19 to request a hearing on an application filed by Centennial Appreciation Portfolio, Series 1 and 2 for an order pursuant to Section 8(f) of the Investment Company Act declaring that it has ceased to be an investment company. (Rel. IC-20365 - June 21)

FIRST XEROX LIFE INSURANCE COMPANY, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting First Xerox Life Insurance Company (Company), First Xerox Variable Annuity Account One (Variable Account) and Xerox Life Sales Company from Sections 26(a)(2)(C) and 27(c)(2) of the Act. The order provides exemptions to the extent necessary to permit the deduction of a mortality and expense risk charge under certain variable annuity contracts from the assets of the Variable Account, or any other separate account established by the Company in the future to support materially similar variable annuity contracts. THE ALGER FUND AND FRED ALGER & COMPANY, INC.

An order has been issued on an application filed by The Alger Fund and Fred Alger & Company, Inc. under Section 6(c) of the Investment Company Act amending a previous order granting relief from Sections 2(a)(32), 2(a)(35), 22(c) and 22(d) of the Act and Rule 22c-1 thereunder. The amended order permits applicants to expand the circumstances under which the Alger Fund may waive a contingent deferred sales charge. (Rel. IC-20367 - June 21)

FORTIS ADVANTAGE PORTFOLIOS, INC., ET AL.

An order has been issued on an application filed by Fortis Advantage Portfolios, Inc., et al. under Section 6(c) of the Investment Company Act for an exemption from Sections 2(a)(32), 2(a)(35), 18(f)(1), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The order permits certain investment companies to issue multiple classes of shares and assess, and under certain circumstances waive, a contingent deferred sales charge. (Rel. IC-20368 - June 21)

THE FIRST TRUST SPECIAL SITUATIONS TRUST, OPPENHEIMER GLOBAL AND TREASURY SECURITIES TRUST, SERIES 1 AND SUBSEQUENT SERIES, ET AL.

An order has been issued on an application filed by The First Trust Special Situations Trust, Oppenheimer Global and Treasury Securities Trust, Series 1 and Subsequent Series, et al. under Sections 6(c), 11(a), 11(c), and 17(d) of the Investment Company Act and Rule 17d-1 thereunder. The order permits series of the Trust to invest in shares of one of certain mutual funds and zero coupon obligations; exempts the sponsor from having to take for its own account or place with others \$100,000 worth of units in the Trust; permits the Trust to distribute capital gains resulting from redemptions of fund shares within a reasonable time after receipt; permits the waiver of any contingent deferred sales charge otherwise applicable on fund shares that the Trust has purchased; permits certain offers of exchange involving the Trust; and permits certain affiliated transactions involving the Trust. PAYDEN & RYGEL INVESTMENT GROUP, ET AL.

A conditional order has been issued under Section 6(c) of the Investment Company Act exempting applicants from Sections 18(f), 18(g), and 18(i) of the Act. The order permits the existing and future investment portfolios of Payden & Rygel Investment Group to create two classes of shares. (Rel. IC-20370 - June 21)
