RULES AND RELATED MATTERS

FINANCIAL DATA SCHEDULES IMPLEMENTED, REVISED EDGAR FILER MANUAL ADOPTED AND MINOR AMENDMENTS TO EDGAR RULES PROPOSED

The Commission today issued three releases relating to the Electronic Data Gathering, Analysis, and Retrieval (EDGAR) system filings implementing regulations, whereby most correspondence processed by the Divisions of Corporation Finance and Investment Management will be submitted electronically. (Release No. 33-7072) announces that Financial Data Schedules will be required in connection with appropriate filings on or after September 1, 1994, and adopts certain clarifying amendments to the rules governing submission of the schedules. The second (Release No. 33-7073) adopts an updated version of the EDGAR Filer Manual which reflects enhancements to EDGARLink and the EDGAR system, including construction and submission of Financial Data Schedules. The third release (Release No. 33-7074) proposes minor technical and clarifying amendments to the EDGAR rules. The proposing release also includes a section addressing common errors made in connection with electronic filing and tips on how to avoid them. INVESTMENT COMPANY ACT RELEASES

THORNBURG INCOME TRUST, ET AL.

A notice has been issued giving interested persons until August 2 to request a hearing on an application filed by Thornburg Income Trust, et al. for an order under Section 6(c) of the Investment Company Act that would exempt applicants from Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) of the Act, and Rule 22c-1 thereunder. The order would permit certain open-end management investment companies to issue multiple classes of shares representing interests in the same portfolio of securities and impose a contingent deferred sales charge on certain redemptions of shares. SELF-REGULATORY ORGANIZATIONS

WITHDRAWAL GRANTED

An order has been issued granting the application of Advanced NMR Systems, Inc. to withdraw from listing and registration its Common Stock, \$.01 Par Value, on the <u>Pacific Stock Exchange</u>. (Rel. 34-34339)

PROPOSED RULE CHANGES

The <u>National Association of Securities Dealers</u> filed a proposed rule change (SR-NASD-94-36) that would reclassify Nasdaq National Market (NNM) securities with respect to the Small Order Execution System (SOES) tier structure and the minimium quotation size requirements for Nasdaq members making markets in such securities. (Rel. 34-34321)

The Chicago Board Options Exchange filed a proposed rule change (SR-CBOE-94-15) relating to solicited transactions. Publication of the notice is expected to appear in the <u>Federal Register</u> during the week of July 11. (Rel. 34-34323)

The <u>New York Stock Exchange</u> filed a proposed rule change (SR-NYSE-94-18) to revise its Allocation Policy and Procedures. Publication of the proposal is expected to be made in the <u>Federal Register</u> during the week of July 11. (Rel. 34-34325)

The Chicago Board Options Exchange filed a proposed rule change (SR-CBOE-94-02) to impose fees on market makers who fail to observe certain participation duties on the Retail Automated Execution System (RAES) for equity and Standard & Poor's 500 Index (SPX) classes of options. Specifically, the CBOE proposes to amend CBOE Rules 8.16, "RAES Eligibility in Equity Options" and 24.16, "RAES Eligibility in SPX/NDX,"

to impose the following fees for failures to satisfy the rules' logoff requirements: a fee of \$100.00 for one to three failures within
one twelve-month period; a fee of \$250.00 for four to six failures
within one twelve-month period; and a fee of \$500.00 for seven or more
failures within one twelve-month period. In addition, the CBOE proposes
to issue a Regulatory Circular clarifying market makers' RAES
responsibilities with respect to equity and SPX options classes.
Publication of the notice is expected to appear in the Federal Register
during the week of July 11. (Rel. 34-34329)

The New York Stock Exchange filed a proposed rule change (SR-NYSE-94-23) relating to the Content Outline for the General Securities Sales Supervisor (Series 8) Examination. Publication of the proposal is expected to be made in the <u>Federal Register</u> during the week of July 11. (Rel. 34-34335)

The New York Stock Exchange filed a proposed rule change (SR-NYSE-94-24) relating to examination specifications for the General Securities Sales Supervisor (Series 8) Examination. Publication of the proposal is expected to be made in the <u>Federal Register</u> during the week of July 11. (Rel. 34-34336)

The New York Stock Exchange filed a proposed rule change (SR-NYSE-94-26) that relates to the examination specifications for the General Securities Registered Representative (Series 7) Examination. Publication of the proposal is expected in the Federal Register during the week of July 11. (Rel. 34-34341)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The <u>Midwest Clearing Corporation</u> filed a proposed rule change (SR-MCC-94-08) to waive certain fees. The rule change was effective upon filing. (Rel. 34-34326)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change (SR-PSE-93-31) and Amendment No. 1 thereto, filed by the <u>Pacific Stock Exchange</u> relating to amendments to its Minor Rule Plan. Publication of the approval order is expected to appear in the <u>Federal Register</u> during the week of July 11. (Rel. 34-34322)

The Commission approved a proposed rule change (SR-MSTC-94-04) filed by the <u>Midwest Securities Trust Company</u>. The rule change establishes the Limited Purpose Participant Program. (Rel. 34-34324)

The Commission approved a proposed rule change submitted by the <u>New York Stock Exchange</u> (SR-NYSE-93-38) to add NYSE Rules 304(h)(2), 345.12, 346(b) and (e), 346(f), 352(b) and (c), 440C and 472(c) to the list of exchange rule violations and fines applicable thereto pursuant to Rule 476A and to amend the NYSE minor rule violation enforcement and reporting plan accordingly. The Commission approved a proposed rule change submitted by the New York Stock Exchange (SR-NYSE-94-13) relating to an Interpretation to Rule 345 to establish a new category of limited registration for floor clerks of members engaged in public business with professional customers and to adopt the Series 7B Examination and the corresponding Content Outline for the Examination Module for Floor Clerks of Members Engaged in Public Business with Professional Customers. (Rel. 34-34334)

ACQUISITIONS OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
