PROPOSED RULE AND FORM AMENDMENTS REGARDING ACCOUNTING FOR INVESTMENT COMPANY EXPENSES

The Commission has issued a release proposing for public comment amendments to Regulation S-X and investment company registration forms that would require an investment company to reflect in its financial statements, fee table, and financial highlights table and in the calculation of its yield the cost of fund services paid for by brokers in exchange for the direction of fund commissions to the broker. PROPOSED AMENDMENTS TO SECTION 16 RULES

On August 10, the Commission issued a release (Release No. 34-34514) proposing for public comment amendments to its rules and forms regarding the filing of ownership reports by officers, directors, and ten percent shareholders, and the exemption by those persons from the short-swing profit recovery provisions of Section 16 of the Securities Exchange Act of 1934 and related provisions of the Investment Company Act of 1940 and the Public Utility Holding Company Act of 1935. The proposed rules are intended to streamline the Section 16 regulatory scheme, particularly with respect to employee benefit plans, and codify several staff interpretive positions.

Comments should be submitted in triplicate to Jonathan G. Katz, Secretary, Securities and Exchange Commission, 450 Fifth Street, N.W., Mail Stop 6-9, Washington, D.C. 20549. Comments must be received on or before [60 days after Federal Register publication], and should refer to File No. S7-21-94. All submissions will be available for inspection in the Public Reference Room.

On the same date, the Commission also issued a release (Release No. 34-34513) extending the phase-in date for compliance with current Rule 16b-3 to September 1, 1995, or such different date as set forth in further rulemaking under Section 16. INVESTMENT COMPANY ACT RELEASES

NORTH AMERICAN SECURITY LIFE INSURANCE COMPANY, ET AL.

An order has been issued exempting North American Security Life Insurance Company, NASL Variable Account (Variable Account), NASL Financial Services, Inc. and Wood Logan Associates Inc. from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Investment Company Act. The order provides exemptions to the extent necessary to permit the deduction from the assets of the Variable Account of a mortality and expense risks charge imposed under certain flexible purchase payment individual and group deferred variable annuity contracts. (Rel. IC-20468 - August 10)

FIRST NORTH AMERICAN LIFE ASSURANCE COMPANY, ET AL.

An order has been issued exempting First North American Life Assurance Company, FNAL Variable Account (Variable Account), NASL Financial Services, Inc. and Wood Logan Associates Inc. from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Investment Company Act. The order provides exemptions to the extent necessary to permit the deduction from the assets of the Variable Account of a mortality and expense risks charge imposed under certain flexible purchase payment individual deferred variable annuity contracts. (Rel. IC-20470 - August 10)

CHUBB LIFE INSURANCE COMPANY OF AMERICA, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting Chubb Life Insurance Company of America (Chubb Life), Chubb Separate Account C, any other separate account established in the future by Chubb Life or an affiliated life insurance company to support scheduled premium, single premium, or flexible premium variable life insurance contracts (Contracts), and Chubb Securities Corporation from the provisions of Section 27(c)(2) of the Act and Rules 6e-2(c)(4)(v) and 6e-3(T)(c)(4)(v) thereunder. The order provides exemptions to the extent necessary to permit applicants to deduct from premium payments received an amount approximately equal to the increase in Chubb Life's federal tax liability resulting from Chubb Life's receipt of premium payments in connection with the Contracts. HOLDING COMPANY ACT RELEASES

WPS RESOURCES CORPORATION

An order has been issued authorizing WPS Resources Corporation (WPS Resources) to acquire all the outstanding shares of common stock of Wisconsin Public Service Corporation, a Wisconsin electric and gas public-utility holding company exempt from registration by order of the Commission under Section 3(a)(2) of the Act, and, through such acquisition, 33.1% of the outstanding shares of Wisconsin River Power Company. In addition, WPS Resources and its subsidiary companies have been granted, upon consummation of the proposed transaction, an exemption under Section 3(a)(1) of the Act from all of the provisions of the Act, except Section 9(a)(2). PROPOSED RULE CHANGE

The Government Securities Clearing Corporation filed a proposed rule change (SR-GSCC-94-06) modifying the trade reporting requirements for category 2 inter-dealer broker netting members.
