COMMISSION ANNOUNCEMENTS

U.S. SECURITIES AND
EXCHANGE COMMISSION

LARRY E. BERGMANN APPOINTED ASSOCIATE DIRECTOR

Richard G. Ketchum, Director of the Division of Market Regulation, announced the appointment of Larry E. Bergmann as Associate Director in charge of the Division's Office of Legal Policy and Trading Practices, a Senior Executive Service position.

Mr. Bergmann graduated from the Massachusetts Institute of Technology in 1971, and from Boston College Law School (cum laude), where he served as an Articles Editor of the law review, in 1975. He joined the Commission's New York Regional Office in 1975 as an Enforcement attorney. In 1978, Mr. Bergmann joined the Branch of Regional Office Assistance in the Commission's Headquarters Division of Enforcement. He became a Branch Chief in that Division, and in 1984 became Assistant Director in the Office of Trading Practices in the Division of Market Regulation. (Press Release 88-40)

CIVIL PROCEEDINGS

PERMANENT INJUNCTION ENTERED AGAINST DENNIS A. THOMAS

The Chicago Regional Office announced that on April 8 U.S. District Judge Philip M. Pro, District of Nevada, entered a Final Judgment of Permanent Injunction against Dennis A. Thomas. The Judgment permanently enjoins Thomas from further violations of the registration, antifraud, and broker-dealer registration provisions of the securities laws. Thomas, without admitting or denying the facts alleged, consented to the Order.

The November 14, 1986 Complaint alleged that from January 1, 1982 to April 1984, Thomas raised \$2.2 million from numerous investors through the sale of stock in several companies. The Complaint further alleges that Thomas made and caused to be made to investors material misrepresentations and omissions concerning, among other things, the use of proceeds, the profitability of the investment, the risks associated with an investment, and the existence or likelihood of a future public trading market in the issuer's securities. Additionally, the Complaint alleges that Thomas acted as an unregistered broker and sold his own unregistered stock in one of the companies through Malcolm Kanan, his broker at the time. (SEC v. HOLDING COMPANY ACT RELEASES

OHIO POWER COMPANY

An order has been authorizing Ohio Power Company, subsidiary of American Electric Power Company, to sell certain items of its electric power distribution equipment to Procter & Gamble Manufacturing Co. (Rel. 35-24635 - May 3)

GENERAL PUBLIC UTILITIES CORPORATON

A supplemental order has been issued authorizing a proposal by General Public Utilities Corporation, a registered holding company, and its subsidiaries, Jersey Central Power & Light Company, Metropolitan Edison Company, and Pennsylvania Electric Company (collectively, Utility Companies), for additional capital contributions to be made to the Utility Companies' subsidiary, Saxon Nuclear Experimental Corporation, from time-to-time through December 31, 1989 in an aggregate amount not to exceed \$13 million. TRUST INDENTURE ACT RELEASES

CITICORP

A notice has been issued giving interested persons until May 26 to request a hearing on an application by Citicorp, a Delaware corporation, under Section 310(b)(1)(ii) of the Trust Indenture Act of 1939. The application declares that the trusteeship of United States Trust Company of New York under four Citicorp indentures and under a Pooling and Servicing Agreement of Citicorp Mortgage Securities, Inc., subsidiary of Citicorp, with respect to Citicorp's obligations as guarantor, is not so likely to involve a material conflict of interest as to make it necessary in the public interest or for the protection of investors to disqualify the Trust Company from acting as trustee under any of these indentures or the Agreement. ACQUISITIONS OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent.
