ADMINISTRATIVE PROCEEDINGS

LESLIE LIVINGSTON AND AFFILIATES ORDERED TO CEASE AND DESIST

The Commission settled administrative proceedings against Leslie T. Livingston of Portland, Oregon, and two related entities, Livingston & Company and Livingston Securities, Inc. Respondents consented to the entry of a Commission Order finding that respondents violated the reporting requirements of Section 13(d) of the Securities Exchange Act of 1934 (Exchange Act) and Rules 13d-1 and 13d-2 thereunder, and that respondent Livingston was a cause of those violations. Respondents neither admitted nor denied the Commission's findings.

The proceedings arose out of the August 1990 change in control of the board of directors of Comprehensive Care Corporation, a health care management concern headquartered in Chesterfield, Missouri. The Order requires respondents to cease and desist, pursuant to Exchange Act Section 21C, from violating or causing violations of Section 13(d) of the Exchange Act and Rules 13d-1 and 13d-2 thereunder. APPEAL OF APPLICATION OF LIBERTY BROKERAGE, INC. TO EMPLOY FRANK KOCHKA DISMISSED

The Commission has dismissed the appeal of Liberty Brokerage, Inc. to employ Frank J. Kochka. Kochka is subject to a statutory disqualification on the basis of his February 1988 guilty plea to using the telephone to facilitate a cocaine conspiracy. In March 1991, Kochka was hired by Liberty. Liberty submitted a Form U-4 which failed to reveal Kochka's felony conviction. Although the NASD had not approved Kochka's association with Liberty, Kochka was permitted to work as a registered representative at Liberty.

The Commission found that Kochka's conviction was particularly serious since it involved his assisting in drug sales to his co-workers at another securities firm. The Commission further found that Liberty had not demonstrated that its existing supervisory procedures were adequate. (Rel. 34-31792)

CEASE AND DESIST ORDER ENTERED AGAINST THE BOSTON COMPANY, INC.

On February 4, the Commission announced the institution of administrative proceedings pursuant to Section 21C of the Securities Exchange Act of 1934 (Exchange Act), and entry of an Order that The Boston Company, Inc. (Boston Co.) permanently cease and desist from committing or causing any violations and any future violations of Sections 13(a) and 13(b)(2)(A) of the Exchange Act and Rules 12b-20, 13a-13 and 13b2-1 thereunder. The Commission simultaneously accepted an Offer of Settlement in which Boston Co. consented to the entry of the Order without admitting or denying the Commission's findings.

The Commission found that Boston Co., for the first three quarters of 1988, reported materially overstated income figures to its parent Shearson Lehman Brothers, Inc. (Shearson Inc.), which is wholly owned by Shearson Lehman Brothers Holdings, Inc. (Shearson Holdings), due to improper accounting practices, non-GAAP accounting judgments and lack of internal controls at Boston Co. As a result, Shearson Inc. and Shearson Holdings each overstated their net incomes on their respective Forms 10-Q during the period by a total of \$30 million. (Rel. 34-31822)

ADMINISTRATIVE PROCEEDINGS AGAINST FINANCIAL MANAGEMENT GROUP OF VIRGINIA, INC. AND MICHAEL WHELCHER

The Commission instituted public administrative proceedings, made findings and imposed remedial sanctions under Sections 203(e) and 203(f) of the Investment Advisers Act (Advisers Act) against Financial Management Group of Virginia, Inc. (Financial Management), a registered investment adviser, and Michael A. Whelchel (Whelchel), president and chairman of the board of Financial Management.

The Commission accepted Offers of Settlement from Financial Management and Whelchel wherein they consent to entry of an Order containing findings that on November 27, 1992, Financial Management was permanently enjoined from future violations of Section 15(a)(1) of the Securities Exchange Act of 1934 (Exchange Act) and Section 204 of the Advisers Act. The Order also contained findings that Whelchel was permanently enjoined from future violations of the antifraud provisions of the federal securities laws and Section 203(a) of the Advisers Act, and from aiding and abetting violations of Section 15(a)(1) of the Exchange Act. Furthermore, the Order contains findings that Whelchel engaged in a fraudulent scheme to misappropriate investors' proceeds through use of false and misleading representations. In addition, the Order finds that Whelchel caused Financial Management and WL Financial, Inc. (WL) to operate as unregistered broker-dealers and caused WL to operate as an unregistered investment adviser. Finally, the Order finds that Financial Management violated various recordkeeping provisions of the Advisers Act. (Rel. IA-1361)

TRADING SUSPENSIONS

TRADING SUSPENSION IN ENROTEK PROPERTIES INC., A/K/A ENROTEK LTD.

The Commission announced, pursuant to Section 12(k) of the Securities Exchange Act of 1934 (Exchange Act), the temporary suspension of over-the-counter trading of the

securities of Enrotek Properties Inc., a/k/a Enrotek Ltd. (Enrotek), a Nevada corporation located in Calgary, Canada, for a ten business-day period commencing at 5:15 P.M. (EST), February 4, 1993 and terminating at 12:00 P.M., midnight (EST), February 18, 1993.

Trading has been suspended in view of questions that have been raised about the adequacy and accuracy of public information concerning, among other things, Enrotek's financial statements in a Form 10 registration statement, which became effective on February 4, 1993, by operation of law under the provisions of the Exchange Act. HOLDING COMPANY ACT RELEASES

PENNSYLVANIA ELECTRIC COMPANY

A supplemental order has been issued authorizing a proposal by Pennsylvania Electric Company (Penelec), an electric public-utility subsidiary company of General Public Utilities Corp., a registered holding company. Penelec proposes to sell, on or before June 30, 1993, to Advanced Cast Products, Inc., a nonassociate company, for a cash purchase price of \$140,000, certain electric substation facilities and equipment located in Vernon Township, Crawford County, Pennsylvania. (Rel. 35-25740)

ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
