## SELF-REGULATORY ORGANIZATIONS

### APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change (SR-PHLX-92-10) filed by the Philadelphia Stock Exchange which amends PHLX Rule 1024 to allow the PHLX to grant waivers to sell foreign currency options on the PHLX, under specified conditions, to registered representatives who passed the Series 7 General Securities Representative Examination prior to June 1986. Publication of the proposal is expected in the Federal Register during the week of October 4. (Rel. 34-32990)

The Commission approved on an accelerated basis a proposed rule change (SR-PHLX-92-31) filed by the Philadelphia Stock Exchange to extend until 4:15 p.m. Eastern Time (ET) or five minutes after the close of trading the deadline for submitting exercise advices and memoranda to exercise American-style industry index options on non-expiration Fridays. The proposal also extends until 4:20 p.m. ET or five minutes after the close of trading the deadline for submitting exercise advices and memoranda to exercise National Over-the-Counter Index options. Publication of the proposal is expected in the Federal Register during the week of October 4. (Rel. 34-32991)

PROPOSED RULE CHANGE

The New York Stock Exchange filed a proposed rule change (SR-NYSE-92-37) to amend NYSE Rule 13 (Definitions of Orders) to permit entry of a "Limit-at-the-Close Order. Publication of the proposal is expected in the Federal Register during the week of October 4. (Rel. 34-32994)
