# COMMISSION ADOPTS AMENDMENTS TO SEGMENT REPORTING RULES TO COMPORT WITH REVISED GAAP REQUIREMENTS

On January 5, the Commission issued a release adopting amendments to its reporting requirements that conform them with the revised requirements of the Financial Accounting Standards Board's Statement of Financial Accounting Standards (SFAS) No. 131, governing disclosures relating to a business enterprise's operating segments. ### INVESTMENT COMPANY ACT RELEASES

# FRANKLIN GOLD FUND, ET AL.

A notice has been issued giving interested persons until February 1, 1999, to request a hearing on an application filed by Franklin Gold Funds, et al. for an order under Section 12(d)(1)(J) of the Investment Company Act exempting applicants from Sections 12(d)(1)(A) and (B) of the Act, under Sections 6(c) and 17(b) of the Act exempting applicants from Section 17(a) of the Act, and under Rule 17d-1 under the Act permitting certain joint transactions. The order would permit certain registered management investment companies and private accounts to invest their uninvested cash and cash collateral in money market funds and engage in certain transactions with each other. The order also would amend a prior order. (Rel. IC-23633 - January 5)

#### CABLEUROPA S.A.

An order has been issued on an application filed by Cableuropa S.A. (Cableuropa) under Section 6(c) of the Investment Company Act exempting a special purpose vehicle (SPV) from all provisions of the Act. The order permits SPV to sell certain debt securities and use the proceeds to finance the business activities of Cableuropa and companies directly or indirectly controlled by Cableuropa. (Rel.
