COMMISSION ANNOUNCEMENTS

ORDER ISSUED SUSPENDING TRADING IN THE SECURITIES OF GOLDEN MOUNTAIN, INC. AND METRO MATCH, INC.

The Commission announced the temporary suspension, pursuant to Section 12(k) of the Securities Exchange Act of 1934, of over-the-counter trading of the securities of Golden Mountain, Inc. (Golden Mountain) and Metro Match, Inc. (Metro Match) of Los Angeles, California and Las Vegas, Nevada, respectively, at 9:30 a.m. EST on February 22, 1999, and terminating at 11:59 p.m. EST on March 5, 1999.

The Commission's Order of Suspension of Trading arose from concerns that there was a lack of current, adequate and accurate information regarding the securities of Golden Mountain and Metro Match. Questions have been raised about the adequacy and accuracy of publicly disseminated information concerning, among other things, the business prospects of each entity and the identity of the persons in control of the operations of each entity. INVESTMENT COMPANY ACT RELEASES

OLD MUTUAL SOUTH AFRICA EQUITY TRUST

An order has been issued under Section 8(f) of the Investment Company Act declaring that Old Mutual South Africa Equity Trust has ceased to be an investment company. (Rel. IC-23698 - February 17)

MORGAN STANLEY DEAN WITTER VARIABLE INVESTMENT SERIES

A notice has been issued giving interested persons until March 12, 1999, to request a hearing on an application filed by Morgan Stanley Dean Witter Variable Investment Series seeking an order exempting it from the provisions of Section 17(a) of the Investment Company Act to the extent necessary to permit the reorganization of its Capital Appreciation Portfolio into its Equity Portfolio. THE VICTORY PORTFOLIOS, ET AL.

An order has been issued on an application filed by The Victory Portfolios, et al. under Section 17(d) of the Investment Company Act and under Rule 17d-1 under the Act. The order permits The Victory Portfolios to deposit uninvested cash balances in joint accounts investing in short-term investments, and permits Key Trust Company of Ohio, N.A. to accept fees for acting as securities lending agent. HARTFORD LIFE AND ANNUITY INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until March 16, 1999, to request a hearing on an amended and restated application filed by Hartford Life and Annuity Insurance Company, ICMG Registered Variable Life Separate Account One and Hartford Life and Annuity Insurance Company Separate Account Six (together with ICMG Registered Variable Life Separate Account One, the Accounts). The application seeks an order pursuant to Section 26(b) of the Investment Company Act that would permit the Accounts to substitute shares of the Bond Portfolio, Diversified Equity Portfolio, Diversified Mid Cap Portfolio, Large Cap Growth Portfolio and MidCap Value Portfolio of One Group Investment Trust for shares of the Bond Fund, Growth and Value Fund, Mid Cap Opportunity Fund, Growth Fund and Intrinsic Value Fund of Pegasus Variable Fund currently held by the Accounts. The amended and restated application also seeks an exemption under Section 17(b) of the Act exempting related transactions from Section 17(a) of the Act. (Rel. IC-23701 - February 19)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change by the New York Stock Exchange (SR-NYSE-98-48) permanently approving a pilot program amending paragraph 902.02 of the Exchange's Listed Company Manual to reduce listing fees for amalgamations. Publication of the order is expected in the Federal Register during the week of February 22. (Rel. 34-41054)

The Commission approved a proposed rule change by the New York Stock Exchange (SR-NYSE-98-40) permanently approving a pilot program amending paragraph 902.02 of the NYSE's Listed Company Manual to reduce initial listing fees under certain circumstances. The order will be published in the Federal Register during the week of February 22. (Rel. 34-41055)

The Commission has approved a proposed rule change filed by The Depository Trust Company (SR-DTC-98-13). The rule change establishes certain conditions that if met would allow DTC to collect the difference between a participant's required fund deposit and its actual fund deposit within two business days instead of monthly. (Rel. 34-41067)

WITHDRAWALS GRANTED

An order has been issued granting the application of Tadiran Limited to withdraw its American Depositary Shares (each representing one ordinary share) from listing and registration on the New York Stock Exchange. (Rel. 34-41068)

An order has been issued granting the application of The Petersen Companies, Inc. to withdraw its Class A Common Stock, \$0.01 Par Value, from listing and registration on the New York Stock Exchange. (Rel. 34-41070)

DELISTINGS GRANTED

An order has been issued granting the application of the New York Stock Exchange to strike from listing and registration Coastal Physician Group, Inc., Common Stock, \$0.01 Par Value. (Rel. 34-41069)
