## ENFORCEMENT PROCEEDINGS

---

### **INJUNCTIVE ACTION FILED AGAINST CBT-OHIO, LTD., ANDREW BODNAR, THOMAS BUCK, MICHAEL KEATING, AND KEATING ADVISORY GROUP**

The Commission announced the filing of a complaint on April 8 in the United States District Court for the Northern District of Ohio against CBT-Ohio, Ltd. (CBT-Ohio), Andrew P. Bodnar (Bodnar), Thomas E. Buck (Buck), Michael P. Keating (Keating) and Keating Advisory Group (Keating Advisory). In its complaint, the Commission is seeking a permanent injunction, disgorgement and the imposition of civil penalties against the defendants for violating, among other things, the anti-fraud, securities registration and broker-dealer registration provisions of the federal securities laws.

The complaint alleges that from November 1996 through July 1997, the defendants engaged in a scheme to defraud investors and to misappropriate money through the fraudulent offer and sale of the unregistered securities of CBT Holding Corporation (CBT Holding) and CBT-Ohio. The defendants solicited and induced at least 148 public investors to purchase approximately \$6.4 million of promissory notes issued by CBT Holding and CBT-Ohio. Bodnar, Keating and the others on the salesforce falsely portrayed the securities as certificates of deposit yielding a 12 percent annual return and made other misrepresentations intended to lull investors into the false belief that the securities were safe investments. The complaint alleges that, in reality, Bodnar and Buck misappropriated most, if not all, of the investor funds raised through the sales of the CBT Holding and CBT-Ohio securities.

The complaint alleges that Keating and the others on the salesforce failed to conduct any independent investigation or due diligence on CBT Holding, CBT-Ohio and/or their securities. Nevertheless, Keating, acting through Keating Advisory, touted the safety of the CBT Holding and CBT-Ohio securities. [SEC v. CBT-Ohio, Ltd., Andrew P. Bodnar, Thomas E. Buck, Michael P. ## INVESTMENT COMPANY ACT RELEASES

---

### THE GOLDMAN SACHS GROUP, INC., ET AL.

A notice has been issued giving interested persons until April 28 to request a hearing on an application filed by The Goldman Sachs Group Inc., et al. for an order under Section 6(c) of the Investment Company Act for an exemption from Section 12(d)(3) of the Act. The order would amend a prior order relating to certain registered investment companies advised by Goldman Sachs Asset Management, Liberty Investment Management, Goldman Sachs Asset Management International, and Goldman Sachs Fund Management, L.P, and one or more other investment advisers (Unaffiliated Advisers). The Prior Order permits the portion of the portfolio of these registered investment companies advised by an Unaffiliated Adviser (Unaffiliated Portion) to engage in certain principal and brokerage transactions with and to purchase certain securities from Goldman, Sachs & Co. (Goldman Sachs) or a member of an underwriting syndicate in which Goldman Sachs is a principal underwriter. The requested order would permit the Unaffiliated Portion to purchase equity or debt securities issued by The Goldman Sachs Group, Inc. or an affiliated person of The Goldman Sachs Group, Inc., subject to the limits in Rule 12d3-1 under the Act. ### AMR INVESTMENT SERVICES TRUST, ET AL.

A notice has been issued giving interested persons until May 3, 1999 to request a hearing on an application filed by AMR Investment Services Trust, et al., for an order that would grant relief from Sections 10(f), 17(a), and 17(e) of the Investment Company Act and from Rule 17e-1 under the Act. The order would permit certain registered open-end management investment companies advised by several investment advisers to engage in principal and brokerage transactions with a broker-dealer affiliated with one of the investment advisers and to purchase securities in offerings underwritten by a principal underwriter affiliated with one of the investment advisers. The transactions would be between a broker-dealer or principal underwriter and a portion of the investment company's portfolio not advised by the adviser affiliated with the broker-dealer or principal underwriter. The order also would permit these investment companies not to aggregate certain purchases from an underwriting syndicate in which an affiliated person of one of the investment advisers is a principal underwriter. ### THE EQUITABLE LIFE ASSURANCE SOCIETY OF THE UNITED STATES, ET AL.

A notice has been issued giving interested persons until April 30 to request a hearing on an application filed by The Equitable Life Assurance Society of the United States (Equitable Life), The Equitable of Colorado, Inc. (EOC), Separate Account No. 45 of

Equitable Life, Separate Account No. 49 of Equitable Life, Separate Account VA of EOC, any other separate account established by Equitable Life or EOC in the future to support certain deferred variable annuity contracts and certificates issued thereby, EQ Financial Consultants, Inc., and Equitable Distributors, Inc. (collectively Applicants). Applicants seek an order under Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 2(a)(32), 22(c), and 27(i)(2)(A) of the Act and Rule 22c-1 thereunder to permit the recapture of credits applied to contributions made under certain deferred variable annuity contracts. In addition, Applicants request that the order extend to any other National Association of Securities Dealers, Inc. member broker-dealer controlling or controlled by, or under common control with, Equitable Life or EOC that serves as a distributor or principal underwriter for the Contracts or Future Contracts. ## HOLDING COMPANY ACT RELEASES

### AMERICAN ELECTRIC POWER CO., INC.

An order has been issued approving a proposal by American Electric Power Company, Inc. (AEP), a registered holding company, to: 1) extend the period of authorization (Guarantee Authority) whereby AEP may guarantee the debt of certain nonutility subsidiaries through December 31, 2002; and 2) increase the Guarantee Authority for certain nonutility subsidiaries from \$100 million up to \$200 million. (Rel. 35-26998)

### OHIO POWER COMPANY

An order has been issued authorizing Ohio Power Company, an electric utility subsidiary of American Electric Power Company, Inc., a registered holding company, to acquire and redeem certain air quality development revenue refunding bonds and to issue or acquire certain credit enhancement instruments. (Rel. 35-26999)

### NEW CENTURY ENERGIES, INC., ET AL.

An order has been issued authorizing New Century Energies, Inc. (NCE), a registered holding company, and its subsidiaries to engage in various external and intrasystem financing transactions. In addition, NCE's nonutility subsidiary, NCE Enterprises, Inc., and its subsidiaries, have been authorized to pay dividends out of capital and unearned surplus. Further, certain of NCE's nonutility subsidiaries have been authorized to sell goods and services to certain other nonutility associates at fair market prices under an exemption from Section 13(b) of the Public Utility Holding Company Act. Jurisdiction has been reserved over the issuance of certain securities by NCE and its subsidiaries, the transfer of proceeds from securities sales by certain NCE subsidiaries to NCE, and the sale of goods and services among certain NCE nonutility subsidiaries, pending completion of the record.
