ENFORCEMENT PROCEEDINGS

GREGORY VERNON ENJOINED BY CONSENT

The Commission announced that on July 16, 1999, the Honorable Zita L. Weinshienk, United States District Judge for the District of Colorado entered an order of permanent injunction against Gregory G. Vernon (Vernon) of Denver, Colorado. The order, which was entered pursuant to Vernon's consent, in which he neither admitted nor denied the allegations of the complaint, prohibits him from further violations of the registration, antifraud, and filing provisions of the federal securities laws. Specifically, Vernon is enjoined from further violations of Section 10(b), of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder and Sections 5(a), 5(c), 17(a), and 17(b) of the Securities Act of 1933.

Also on July 16, 1999, the Court entered an order, pursuant to a Commission motion, dismissing with prejudice its allegations against Timberline Consultants, Inc. [SEC v. Golden Eagle International, Inc., Civil Action No. 98-Z-1020, D. Colo.] (LR-16246)

TEMPORARY RESTRAINING ORDER ISSUED AGAINST PRIME BANK SCHEME TARGETING MUNICIPALITIES

A Temporary Restraining Order was issued on August 4 halting the fraudulent activities of Alamin, Inc., Financial Resources, George L. Vaughn, and Curt Arvidson. The Commission's complaint, filed on July 28, 1999, alleged that the defendants had solicited at least 23 municipalities located primarily in the western United States, offering to sell over \$649 million in interests in a prime bank trading program.

While none of the municipalities has invested in the scheme, the Commission alleges that the defendants violated Sections 5(c) and 17(a) of the Securities Act of 1993 by making offers through their fraudulent misrepresentations. Alamin, Inc., Financial Resources, Vaughn, and Arvidson solicited municipalities to put liquid assets into a trust which would be administered by the defendants. The defendants claimed they would use the assets as collateral in a prime bank trading program which was endorsed by the IMF and would guarantee returns of 130% a month with no risk of loss. The

Commission alleges that prime bank schemes do not exist and that the defendants misrepresented the risk of loss and the returns promised:
