This table is organized by "Item Name" and "Purpose."

The purpose of "State, Territorial, or Tribal Program of Screening" is to specify the F.I.P.S. or Tribal Program code for the state, territory, or tribe where screening occurred.

The purpose of "County of Screening" is to specify the F.I.P.S. code for the county of the primary B&C provider.

The purpose of "City of Screening" is to specify the city of the primary B&C provider.

The purpose of "Enrollment Site" is to specify the point of enrollment into the program.

The purpose of "Pap Test Screening Site" is to specify the site where the woman received her Pap test.

The purpose of "Mammogram Screening Site" is to specify the site where the woman received her mammogram.

The purpose of "Patient I.D. Number" is to specify the patient's identification number.

The purpose of "Record Identifier" is to uniquely identify one record among many for a woman.

The purpose of "Record Type" is to specify a patient's record type.

The purpose of "County of Residence" is to specify the F.I.P.S. code for the county of residence.

The purpose of "State or Territory of Residence" is to specify the F.I.P.S. code for the state or territory of residence.

The purpose of "Zip Code of Residence" is to specify zip code of residence.

The purpose of "Date of Birth" is to specify date of birth.

The purpose of "Race 1" is to specify race.

The purpose of "Race 2-6" is to specify a second through sixth race for individuals who choose to identify themselves as multiracial.

The purpose of "Hispanic or Latina Origin" is to specify Hispanic or Latina origin.

The purpose of "Breast Symptoms" is to specify breast symptoms reported by the woman.

The purpose of "Clinical Breast Exam (C.B.E.)" is the provider's assessment of the clinical breast exam.

The purpose of "Date of Clinical Breast Exam (C.B.E.)" is to specify the date of clinical breast exam.

The purpose of "Clinical Breast Exam Paid by N.B.C.C.E.D.P. Funds" is to determine if the C.B.E. was paid for with N.B.C.C.E.D.P. funds.

The purpose of "Previous Pap Test" is to determine if a woman has had a previous Pap test.

The purpose of "Date of Previous Pap Test" is to specify the date of previous Pap test.

The purpose of "Bethesda System Used" is to specify whether the Pap test results for a woman were reported using the 1991 Bethesda System Categories or the 2001 Bethesda System Categories.

The purpose of "Specimen Adequacy of Screening Pap Test" is to give programs a way to report specimen adequacy as noted under the Bethesda System.

The purpose of "Results of Screening Pap Test (Bethesda 1991)" is to report results of screening Pap test using the 1991 Bethesda System.

The purpose of "Specimen Type for Pap Test" is to indicate how the Pap test specimen was collected.

The purpose of "Results of Screening Pap Test (Bethesda 2001)" is to report results of screening Pap test using the 2001 Bethesda System.

The purpose of "Other Screening Pap Test Results" is to specify other screening Pap test results.

The purpose of "Diagnostic Work-Up Planned for Cervical Dysplasia or Cancer" is to indicate the clinical recommendation for immediate diagnostic work-up.

The purpose of "Date of Screening Pap Test" is to specify date of screening Pap test.

The purpose of "Screening Pap Test Paid by N.B.C.C.E.D.P. Funds" is to determine if Pap test, laboratory services, or pelvic exam were paid by N.B.C.C.E.D.P. funds.

The purpose of "Previous Mammogram" is to determine if a woman has had a previous mammogram.

The purpose of "Date of Previous Mammogram" is to specify date of previous mammogram.

The purpose of "Mammography Test Results" is to report results of mammography using the American College of Radiology lexicon.

The purpose of "Diagnostic Work-Up Planned for Breast Cancer" is to indicate the clinical recommendation for immediate diagnostic work-up.

The purpose of "Date of Mammogram" is to specify date of mammography.
