**COMMENT SOUGHT ON A REQUEST FOR DECLARATORY RULING  
FILED BY GENERAL COMMUNICATION, INC.  
REGARDING APPLICATION OF SECTION 54.307(b) OF THE COMMISSION'S RULES**

On January 26, 2009, General Communication, Inc. (GCI) filed a request that the Wireline Competition Bureau issue a declaratory ruling regarding the manner in which competitive eligible telecommunications carriers (ETCs) should report mobile wireless lines eligible for universal service support under section 54.307(b) of the Commission's rules.<sup>1</sup> Specifically, GCI seeks a ruling that its wireless subsidiaries in Alaska: (i) are correctly reporting prepaid wireless lines based on a local address or point of sale address; and (ii) are correctly reporting wireless business lines based on the address to which a service invoice is sent rather than a separate or third-party address from where payments are processed.<sup>2</sup>

Interested parties may file **comments on or before April 20, 2009**, and **reply comments on or before May 5, 2009**. All pleadings are to reference **WC Docket No. 05-337**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.<sup>3</sup>

- Electronic Filers: Comments may be filed electronically using the Internet by accessing the ECFS: <http://www.fcc.gov/cgb/ecfs/>. Filers should follow the instructions provided on the website for submitting comments.
- For ECFS filers, if multiple docket or rulemaking numbers appear in the caption of this proceeding, filers must transmit one electronic copy of the comments for each docket or rulemaking number referenced in the caption. In completing the transmittal screen, filers should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. filing instructions, filers should send an e-mail to [ecfs@fcc.gov](mailto:ecfs@fcc.gov), and include the following words in the body of the message, “get form.” A sample form and directions will be sent in response.

- Paper Filers: Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, filers must submit two additional copies for each additional docket or rulemaking number.

This matter shall be treated as a “permit-but-disclose” proceeding in accordance with the Commission’s *ex parte* rules.<sup>4</sup> Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentation and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and

arguments presented generally is required.<sup>5</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>6</sup>
