COMMENT SOUGHT ON SUNSHINE COMMUNITY HEALTH CENTER REQUEST FOR REVIEW OF DECISION BY THE UNIVERSAL SERVICE ADMINISTRATIVE COMPANY

On February 10, 2009, Sunshine Community Health Center (Sunshine) filed a request seeking review of a decision of the Universal Service Administrative Company (USAC), in which USAC substantially reduced Sunshine's funding request for funding year 2006 under the rural health care support mechanism.¹ In the request, Sunshine argues that USAC incorrectly rejected funding for connections originating in Alaska and terminating in Seattle, Washington.²

Interested parties may file **comments on or before April 20, 2009**, and **reply comments on or before May 5, 2009**. All pleadings are to reference **WC Docket No. 02-60**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.³
