ORDER

By the Deputy Chief, Consumer Policy Division, Consumer & Governmental Affairs Bureau:

- 1. In this Order, we consider the complaint¹ alleging that Silv Communications (Silv) changed Complainant's telecommunications service provider without obtaining authorization and verification from Complainant in violation of the Commission's rules.² We conclude that Silv's actions did result in an unauthorized change in Complainant's telecommunications service provider and we grant Complainant's complaint.
- 2. In December 1998, the Commission released the *Section 258 Order* in which it adopted rules to implement Section 258 of the Communications Act of 1934 (Act), as amended by the Telecommunications Act of 1996 (1996 Act).³ Section 258 prohibits the practice of "slamming," the submission or execution of an unauthorized change in a subscriber's selection of

a provider of telephone exchange service or telephone toll service.⁴ In the *Section 258 Order*, the Commission adopted aggressive new rules designed to take the profit out of slamming, broadened the scope of the slamming rules to encompass all carriers, and modified its existing requirements for the authorization and verification of preferred carrier changes. The rules require, among other things, that a carrier receive individual subscriber consent before a carrier change may occur.⁵ Pursuant to Section 258, carriers are absolutely barred from changing a customer's preferred local or long distance carrier without first complying with one of the Commission's verification procedures.⁶ Specifically, a carrier must: (1) obtain the subscriber's written or electronically signed authorization in a format that meets the requirements of Section 64.1130; (2) obtain confirmation from the subscriber via a toll-free number provided exclusively for the purpose of confirming orders electronically; or (3) utilize an independent third party to verify the subscriber's order.⁷

3. The Commission also has adopted liability rules. These rules require the carrier to absolve the subscriber where the subscriber has not paid his or her bill. In that context, if the subscriber has not already paid charges to the unauthorized carrier, the subscriber is absolved of liability for charges imposed by the unauthorized carrier for service provided during the first 30 days after the unauthorized change. Where the subscriber has paid charges to the unauthorized carrier, the Commission's rules require that the unauthorized carrier pay 150% of those charges to the authorized carrier, and the authorized carrier shall refund or credit to the subscriber 50% of all charges paid by the subscriber to the unauthorized carrier. Carriers should note that our actions in this order do not preclude the Commission from taking additional action, if warranted, pursuant to Section 503 of the Act. 10

We received Complainant's complaint on November 3, 2008, alleging that Complainant's telecommunications service provider had been changed from Verizon to Silv without Complainant's authorization. Pursuant to Sections 1.719 and 64.1150 of our rules, ¹¹ we notified

Silv of the complaint and Silv responded on December 15, 2008. Silv states that authorization was received through a third party verification (TPV). We have reviewed the TPV. The third-party verifier asked the person on the recording, "[y]ou do authorize Silv Communication to be your interstate and intrastate long distance service provider for all the company lines. Yes or no?" The person responded, "yes." InterLATA service in Complainant's state of Virginia includes state-to-state interLATA service, instate interLATA service, and international service. Silv's verifier, only confirmed that Complainant wanted to switch part of a service--which one cannot do. Silv, therefore did not provide clear and convincing evidence that the person on the recording wanted to change interLATA service. We therefore find that Silv's actions resulted in an unauthorized change in Complainant's telecommunications service provider and we discuss Silv's liability below. Silv's liability below.

- 4. Pursuant to Section 64.1170(b) our rules, Silv must forward to Verizon an amount equal to 150% of all charges paid by the subscriber to Silv along with copies of any telephone bills issued from Silv to the Complainant. Within ten days of receipt of this amount, Verizon shall provide a refund or credit to Complainant in the amount of 50% of all charges paid by Complainant to Silv. Complainant has the option of asking Verizon to re-rate Silv's charges based on Verizon's rates and, on behalf of Complainant, seek from Silv any re-rated amount exceeding 50% of all charges paid by Complainant to Silv. Verizon must also send a notice to the Commission, referencing this Order, stating that it has given a refund or credit to Complainant. If Verizon has not received the reimbursement required from Silv within 45 days of the release of this Order, Verizon must notify the Commission and Complainant accordingly. Verizon also must notify the Complainant of his or her right to pursue a claim against Silv for a refund of all charges paid to Silv.
- 5. Accordingly, IT IS ORDERED that, pursuant to Section 258 of the Communications Act of 1934, as amended, 47 U.S.C. § 258, and Sections 0.141, 0.361 and 1.719 of the Commission's rules, 47 C.F.R. §§ 0.141, 0.361, 1.719, the complaint filed by Complainant against Silv Communications IS GRANTED.

If Complainant is unsatisfied with the resolution of this complaint, Complainant may file a formal complaint with the Commission pursuant to Section 1.721 of the Commission's rules, 47 C.F.R. § 1.721. Such filing will be deemed to relate back to the filing date of Complainant's informal complaint so long as the formal complaint is filed within 45 days from the date this order is mailed or delivered electronically to Complainant. *See* 47 C.F.R. § 1.719.

- 6. IT IS FURTHER ORDERED that, pursuant to Section 64.1170(d) of the Commission's rules, 47 C.F.R. § 64.1170(d), Complainant is entitled to absolution for the Verizon nor Silv may pursue any collection against Complainant for those charges.
 - 7. IT IS FURTHER ORDERED that this Order is effective upon release.
