Comment is sought on a petition filed on March 27, 2009 by Smith Bagley, Inc. (Smith Bagley). In its petition, Smith Bagley asks the Commission to increase the level of support provided to qualifying consumers by Tier Four of the universal service low-income Lifeline program from \$25 per month to \$30 per month.<sup>2</sup>

Pursuant to section 1.405 of the Commission's rules, interested parties may file **comments on or before June 3, 2009**, and **reply comments on or before June 18, 2009**. All pleadings are to reference **RM No. 11529**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS), or by filing paper copies.<sup>4</sup>

rulemaking number. Parties may also submit an electronic comment by Internet e-mail. More than a one or two sentence description of the views and arguments presented generally is required.<sup>6</sup> Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in section 1.1206(b) of the Commission's rules.<sup>7</sup>
