Mission:

The mission of USMS is to enforce federal laws and provide support to virtually all elements of the federal justice system by providing for the safety of judges and other court personnel and the security of federal court facilities; apprehending criminals; exercising custody of federal prisoners and providing for their security and transportation to detention facilities; executing federal court orders; seizing assets gained by illegal means and providing for the custody, management and disposal of forfeited assets; assuring the safety of endangered government witnesses and their families; and collecting and disbursing funds.

Resources:

The budget request for FY 2010 totals \$1,152.4 million, including \$1,138.4 million for Salaries and Expenses and \$14 million in Construction for the highest priority projects. This represents a 20.8 percent increase from the FY 2009 enacted level.

Organization:

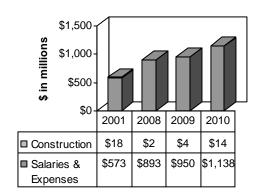
USMS is headed by a Director who is appointed by the President and confirmed by the Senate and the Deputy Director is appointed by the Attorney General.

The USMS has over 400 offices, encompassing the 94 judicial districts and Headquarters, 6 Regional Fugitive Task Forces and 3 foreign field offices. The USMS consists of 6 operational divisions: Judicial Security, Investigative Operations, Witness Security, Prisoner Operations, Tactical Operations, and Justice Prisoner and Alien Transportation System (JPATS). JPATS is one of the largest transporters of prisoners in the world, handling more than 1,000 requests daily to move prisoners between judicial districts, correctional institutions and foreign countries via coordinated air and ground systems. In addition to transporting federal prisoners and detainees, the USMS also houses over 60,000 detainees in federal, state, local and private jails throughout the nation.

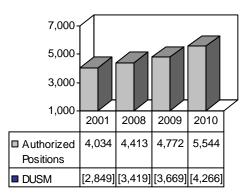
Personnel:

The USMS' authorized positions for FY 2010 total 5,544 positions, including 4,266 Deputy U.S. Marshals (DUSM). Of the total authorized positions, 5,531 are located in domestic offices and 13 are in foreign offices. USMS' FY 2010 request includes an increase of 772 positions, including 597 DUSM over the FY 2009 level of 4,772 authorized positions.

FY 2010 Strategy:

The USMS is tasked with Judicial, courthouse and witness security, prisoner security and transportation, and fugitive apprehensions. For the USMS, one principal area of concern is the capacity of the federal judicial process to respond to increased law enforcement arrests associated with immigration enforcement. Sharp increases in the Department of Homeland Security (DHS) resources and personnel have resulted in constraints and capacity problems. The USMS has been forced to divert resources from fugitive apprehension activities and other mission areas in order to fill the gap which has resulted from increased judicial security in the courtrooms. In some cases, the sheer number of criminal aliens has overwhelmed courthouse cellblock capacity. Increases in DUSM and administrative support personnel will enable the USMS to implement an integrated strategy of protecting the federal judiciary; investigating warrants and arresting fugitives; and handling the prisoner workload resulting from immigration enforcement.

Massive improvements to cellblock capacity and security are critical to handle the current immigration-related workload. Existing limits on infrastructure has made it impossible to reach DHS goals of new arrests. Adding new USMS positions cannot be done without renovating USMS office space and cellblocks within federal courthouses. Renovations affect prisoner-movement space, cellblocks, holding cells, prisoner corridors, sally ports, interview rooms, and prisoner elevators and USMS space. Enhanced systems and applications are required to keep pace with new and expanding government information sharing and communications initiatives. Renovation projects include costs for improvements in information technology infrastructure and security equipment.

FY 2010 Program Changes:

Immigration Enforcement: 700 positions (including 528 DUSM), 350 FTE, and \$144.3 million to address immigration enforcement both at the Southwest Border and within the interior of the country. Request includes \$120.9 million to fill new positions; \$13.5 million to improve the information technology infrastructure. These resources are necessary to ensure the USMS can keep pace with the DHS apprehensions. FY 2010 current services resources for immigration enforcement along the Southwest Border are 778 positions (including 643 DUSM) and \$94.9 million.

Courthouse Renovation: \$10 million to make improvements to cellblock capacity and security. Renovations affect prisoner-movement space (cellblocks, holding cells, prisoner elevators) and USMS space (warrant squads, training rooms, and administrative areas). FY 2010 current services resources for courthouse renovations is \$4 million.
