Identified as Part 14 of the Catalog of Copyright Entries, the first issue available for sale to the public is Volume 26 which includes registrations for the period February-December 1972. Subsequent issues will be published semiannually.

The catalog consists of two sections, the first of which contains names and titles arranged alphabetically and a page number reference to the main entry.
